In producing herewith the arrested accused person namely Soumitra Manna (45 yrs) S/o Lt. Balaram Manna of Rakshyachak, P.S- Kolaghat, Dist-Purba Medinipur along with following seized articles as per seizure list and relevant documents.

I S.I Hara Sundar Mahanty attached with Kolaghat P.S, Dist-Purba Medinipore do hereby lodged a complaint against the above noted accused person to the effect that today (17.06.17) in mid night at about 02.45 hrs received an information from Saibal Pradhan, Register of KTPP Engineering College that one person namely Soumitra Manna is selling different types of foreign liquor (wine) , beer, and I/D liquor from his Xerox centre situated campus of KTPP Engineering College at Rakshyachak under Kolaghat P.S. Accordingly myself informed to O/C Kolaghat P.S and as per his direction myself along with force C/ 388 Arun Mahapatra, C/1575 Chandan Chalak and C/226 Shyamal Chakraborty left P.S for holding raid vide GDE No.- 807 dt 17.06.17 to workout the such information. On reaching the P.O at about 03.35 hrs we found that the above noted accused person is selling the same to the publics from that place.. On getting the smell of arrival of police party the said accused tried to flee away with a Honda Scooty Bearing registration No.- WB- 30V/2706 from there but on a hot chase we managed to apprehend him. On asked he disclosed his identity as mentioned above. On search we are found different types of foreign liquor & I/D liquor i.e i) 05 liters I/D liquor in a Jarikane, ii) Imperial Blue 03 pieces each bottle 750 M.L, iii) Kingfisher Beer 12 pieces each bottle 500 M.L were storage in his house for selling. On demand he fails to produce any valid License, documents, Challan, in support of selling different types of wines, beer, and I/D liquor. Accordingly I arrested him and informed him ground of arrest and also issued memo of arrest. I seized the above noted different types of foreign liquor (wines) , beer, country, I/D liquor and also the motor cycle as mentioned above from his possession after preparing proper seizer list duly signed by the witnesses and the accused person also , took sample from seized articles and labeled it. As the said accused person is running such type of clandestine business without obeying the provision of the Bengal Excise Act. So he is committed offence U/S 46 (A)(b)(c) Bengal Excise Act of 1909. It is also learnt that the above noted accused person selling/storing the different types of wines, beer, and I/D liquor illegally and sell the same to the publics. The seized articles approximate value of Rs. 2580/-.

Therefore I pray that a suitable case may kindly be initiated against the above noted accused person under proper section of law.
