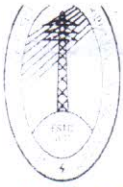

Dear Sir,

I do hereby lodge complaint, empowered by the enabling transitional provision u/s 172 of I.E. act '2003 to the effect that Tarak Nath Das ,S/O-Lt. Santosh Das, of vill: Ramchandrapur,PO-Sajinagachi had committed theft of electricity u/s 135-1(a) of the I.E. ACT'2003 read with amendment act 2007 as stated hereunder:

On 17/06/'17 at about 12:40 P.M. u/s along with technical Staffs Sk Abdul Rouf, L.M. and Hasibul Ali,Hg. T.S.H. of Kolaghat CCC had reached to the commercial premises of Tarak Nath Das ,S/O-Lt. Santosh Das, of vill: Ramchandrapur,PO-Sajinagachi and found that the user Tarak Nath Das is enjoying electricity dishonestly by means of direct hooking from nearby LT line of WBSEDCL through single phase PVC copper wire (Black colour) for commercial purpose, causing loss of revenue of WBSEDCL. Total load inspected at the premises is to the tune of 0.480KW .

As theft of electricity was detected during inspection the portion of hooking device (Black colour PVC copper wire 2.5 mtr. approx.in length) was seized in presence of the witnesses and their signature obtained on the seizure list. The above said hooking articles were duly packed, sealed and labeled at the inspection site and signature of the witnesses obtained on the sealing label. The inspection team left the premises at about 1.25 P.M. on the same date after disconnection of power supply.

The accused Tarak Nath Das has committed an offence U/S 135/1(a) of electricity act 2003 with amendment act 2007. Therefore you are requested to take cognizance of this complaint and treat it as F.I.R.
