Sir,

In producing herewith one arrested accused person namely Dilip Panja(50) S/O Lt. Suresh of Kanchrol, P.S-Kolaghat, Dist.-Purba Medinipur and also seized 10 (Ten) ltrs ID liquor, I ASI Subrata Dasgupta do hereby lodged a written complaint against the above noted accused, to the effect that on 22.06.17 during ASI Subrata Dasgupta to performed his Special raid duty vide Kolaghat B/H GDE NO 702 & vide C.C No-1228 dt. 22.06.17 received source information that someone is running a business of selling ID liquor at his own house at Kanchrol village. After a short while to work out the information myself along with C/339 Rangalal Maity and C/1356 Paritosh Mahato reached at Kanchrol village at 19:05 hrs and found the above noted person is running a business of selling ID liquor at his own house at Kanchrol. Seeing police party the customers fled away but we apprehend the seller namely Dilip Panja(50) S/O Lt. Suresh of Kanchrol, P.S-Kolaghat, Dist.-Purba Medinipur. Accordingly myself along with forces detained the said person and I asked the local people to accompany us for search. But none could come forward. So, in presence of police witnesses search his own house and the below noted liquors are found.

1. One Jar-cane containing 10 (Ten) Ltrs I/D liquor worth RS 400/- (10X40/-=Rs 400/-) [Approximate]

I asked Dilip Panja about the any valid documents or license for the stock and selling of the liquor and any paper of regarding possession of such quantity of liquor. On our interrogation confessed that he is running his business since few months ago without any license or valid documents. So, I seized the above noted articles under proper seizure list and duly signed by the police witnesses who were with me and labeled it. I also extracted one (01) bottle from seized articles SL No-1 as test sample and arrested Dilip Panja(50) S/O Lt. Suresh of Kanchrol, P.S-Kolaghat, Dist.-Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally, maintaining all norms of honorable Apex court. Searched him well but found nothing without his W/A. The accused has been rendered all sorts of facilities as per guideline of Law.

Hence, I pray a cog case may kindly be started against the accused namely Dilip Panja(50) S/O Lt. Suresh of Kanchrol, P.S-Kolaghat, Dist.-Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
