Dear Sir,

I do hereby lodge complaint, empowered by the enabling transitional provision u/s 172 of I.E. act 2003 to the effect that Kartick Mal S/O Santi Mal of Vill: Kumarhat, PO- Pulsita, Dist-Purba Medinipur had committed theft of electricity u/s 135-1(a) of the I.E. ACT 2003 read with amendment act 2007 as stated hereunder:


On 10/02/17 at about 12:05 P.M. u/s along with technical Staffs Sri Arnab Santra, SAE(E) and Sk. Hasibul Ali, Sr.T.S.H. of Kolaghat CCC had reached to the agricultural premises of Kartick Mal at Vill: Kumarhat, PO-Pulsita and found that the user Kartick Mal is enjoying electricity dishonestly by means of direct hooking from nearby LT line of WBSEDCL through single phase PVC copper wire (Yellow colour) for agriculture purpose, causing loss of revenue of WBSEDCL. Total load inspected at the premises is to the tune of 0.6 KVA.

As theft of electricity was detected during inspection the portion of hooking device (Yellow colour PVC copper wire 2 mtr. approx. in length) was seized in presence of the witnesses and their signature obtained on the seizure list. The above said hooking articles were duly packed, sealed and labeled at the inspection site and signature of the witnesses obtained on the sealing label. The inspection team left the premises at about 05:30 P.M. on the same date after disconnection of power supply.


