Sir,

In producing herewith arrested accused person namely Sd. Abdul Gafur (42 yrs) S/o Lt. Sd. Sujaut Hossain of village Barparit, P.S- Kolaghat, Dist- Purba Medinipur along with seized articles 09 (nine) liters of I/D Liquor in one plastic Jaricane as per seizure list and relevant documents.

I S.I Debabrata Bera attached with Kolaghat P.S, Dist-Purba Medinipur do hereby lodged a complaint against the above noted accused person to the effect that on 21.02.17 at 18.15 hrs myself along with force C/1575 Chandan Chalak and C/ 36 Birendranath Guria of Kolaghat P.S, vide GDE No.-1059 dt. 21.02.17 left P.S were engaged for performing special raid against running illegal business, manufacturing, storing and selling of I/D liquor under Kolaghat PS area. During this duty at about 18.25 hrs myself received information from an unknown caller that one person is selling I/D liquor at Deulia Bazar by the side of N.H- 6 under Kolaghat P.S. On receiving such information myself along with force had been to the above place to work out the said information. On reaching there at about 19.55 hrs myself found that the above noted person is selling I/D liquor to the customer from there. Then we are proceeding towards the person silently. But on getting smell on arrival of the police the seller of liquor with customer started escaping form there. On a hot chase we are able to apprehend him while other customer flees away. On search we are found I/D liquor in a plastic Jaricane from his possession. Being asked he disclosed his identity as mentioned above. On demand he fails to produce any valid License, documents, Challan, in support of such I/D liquor. Accordingly, myself arrested him and informed him ground of arrest and also issued memo of arrest. I have seized one plastic Jaricane containing 09 (nine) Liters I/D liquor from his possession after preparing proper seizer list duly signed by the accompanied witnesses and the accused person also. I took sample from seized articles in a bottle and also labeled it. As the said accused person is running such type of clandestine business without obeying the provision of the Bengal Excise Act. So he is committed offence U/S 46 (A)(c) Bengal Excise Act of 1909. It is also learnt that the above noted accused person selling ID liquor illegally and sell the same to the publics. The seized articles (I/D liquor) is approx value of Rs. 540/-

Therefore I pray that a suitable case may kindly be initiated against accused person namely Sd. Abdul Gafur Khan (42 yrs) S/o Lt. Sd. Sujaut Hossain of village Barparit, P.S- Kolaghat, Dist- Purba Medinipur under proper section of law.


