In producing herewith one arrested accused person namely Smt. Abha Rani Das (27) D/O Lt. Nakul Das of Uttar Tentultala PS- Dashpur, Dist.- Paschim Medinipur and also seized 10 (Ten) Ltrs ID liquor, I SI Saurav Chinya of Kolaghat Beat House do hereby lodged a written complaint against the above noted accused, to the effect that on 11/03/17 during mobile duty vide Kolaghat B/H GDE NO. 312 dt. 11/03/17 received telephonic information from reliable source that one woman is coming towards Kolaghat Bus bridge area who is supplier of ID liquor. After a short while to work out the information myself along with C/940 Prashanta Hazra, C/1356 Poritosh Mahata and LCVF Supriya Das reached at Kolaghat Bus Bridge Area at 14:55 hrs. At about 15:20 hrs we see that one woman with a nylon bag is coming towards Kolaghat bus Bridge area. As per source identification we encircled the person. There after maintaining all formalities LCVF Supriya Das stopped her. On being searched her nylon bag which she was carrying by the said LCVF the below noted articles was found.

1. One Jar-cane containing 10 (Ten) Ltrs I/D liquor worth RS 500/- (10X50/- =Rs 500/-) [Approximate]

I asked Abha Rani Das about the any valid documents or license for the stock and selling of the liquor and any paper of regarding possession of such quantity of liquor. On being interrogation he disclosed his identity as mention above. She also confessed that she is carrying ID liquor without any license or valid documents. So, I seized the above noted articles along with the nylon bag under proper seizure list and duly signed by the police witnesses who were with me and labeled it. I also extracted one (01) bottle from seized articles SL No-1 as test sample and arrested Abha Rani Das (27) D/O Lt. Nakul Das of Uttar Tentultala PS- Dashpur, Dist.- Paschim Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally, maintaining, all norms of honaurable Apex court. On being interrogation she also stated that her husband left her. Now she is living at her paternal house. So, I informed her paternal family members over telephone about her arrest. The accused has been rendered all sorts of facilities as per guideline of Law.

Hence, I pray a cog case may kindly be started against the accused namely Smt. Abha Rani Das (27) D/O Lt. Nakul Das of Uttar Tentultala PS- Dashpur, Dist.- Paschim Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
