Sir,

In producing herewith one arrested accused person namely Mahadev Guchait (45) S/O Lt. Janaki Guchait of Kolagachia , P.S-Kolaghat, Dist.-Purba Medinipur and also seized 05 (Five) ltrs ID liquor, I ASI Tarun Talukdar do hereby lodged a written complaint against the above noted accused, to the effect that on 22/03/17 during ASI Tarun Talukdar evening mobile duty vide Kolaghat B/H GDE NO. 656 dt. 22/03/17 received source information that someone is running a business of selling ID liquor at a temporary shop at Kolagachia village . After a short while to work out the information myself along with C/37 Asto Baiary and NVF Tapash Khamrui reached at Kolagachia village at 17:30 hrs and found the above noted person is running a business of selling ID liquor at a temporary shop at Kolagachia . Seeing police party the customers fled away but we apprehend the seller namely Mahadev Guchait (45) S/O Lt. Janaki Guchait of Kolagachia , P.S-Kolaghat, Dist.-Purba Medinipur. Accordingly myself along with forces detained the said person and I asked the local people to accompany us for search. But none could come forward. So, in presence of police witnesses search his temporary shop and the below noted liquors are found.

- 1. One Jar-cane containing 05 (Five) ltrs I/D liquor worth RS 200/- (05X40/- =Rs 200/-) [Approximate]

I asked Mahadev Guchait about the any valid documents or license for the stock and selling of the liquor and any paper of regarding possession of such quantity of liquor. On our interrogation confessed that he is running his business since few months ago without any license or valid documents. So, I seized the above noted articles under proper seizure list and duly signed by the police witnesses who were with me and labeled it. I also extracted one (01) bottle from seized articles SL No-1 as test sample and arrested the Mahadev Guchait (45) S/O Lt. Janaki Guchait of Kolagachia , P.S-Kolaghat, Dist.-Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally, maintaining all norms of honourable Apex court. Searched him well but found nothing without his W/A. The accused has been rendered all sorts of facilities as per guideline of Law.

Hence, I pray a cog case may kindly be started against the accused namely Mahadev Guchait (45) S/O Lt. Janaki of Kolagachia , P.S-Kolaghat, Dist.-Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
