The Complainant above named most respectfully states & prays as here under :-

That on 02/09/2016 at about 10 am. all on a sudden the accused persons as named above with common intention forcibly entered in the Courtyard of Complainant's House being armed with sword, Kathari, Iron Rod, and with filthy language. The complainant protested against ill motive and acts of the accused persons.

Being protested all the accused persons jumped upon complainant and attacked her. Accused no-2 assaulted with Iron Rod in the left Eye of the complainant. As a result she lost her eye sight immediately and sustained injury. Accused No.-1, 3, & 4 tormented complainant's wearing Sari & Blouse. As a result she became half naked and Caused outrage of her modesty. Even those accused persons pressed upon her breasts. Accused No- 2 & 5 snatched a neckless made of gold of 12 ana from neck of the complainant.

Two sons of brother of Complainant's husband namely Mustakin Nayek & Mofijul Nayek along with other lady neighbours tried to rescued the complainant. Accused No- 1 assaulted upon the head of Mustakin by Sabal (Iron Rod) to murder him. Mustakin tried to save his head with hands. As a result, bones of right elbow and wrist was fractured and he got gravious injury. Rest accused persons assaulted him with brick bat and lathi. Accused persons injured Mofijul Nayek with brick bats. As a result he got bleeding injury over his right eye. Husband of the complainant rushed on the place of incidents. Accused no.- 3 assaulted him by Kathari. As a result he got cut & bleeding injury on his right hand. Thereafter the accused persons went away.

Thereafter the complainant and injured persons went to Kolaghat Police Station. There from they went to Paikpari BPHS as per direction of police. Injured Mustakin admitted in the Said Hospital and rest three injured persons got primary treatment from the said Hospital.

Complainant lodged a written complaint at Kolaghat P.S. on the same day. Police of the Kolaghat P.S. lodged G.D.E. no.- 96, dt. 02/09/2016. Police did not treat the complaint as an F.I.R. After waiting for few days complainant lodged the same complaint before the office of S.P. Tamluk and S.D.P.O. Tamluk on 08/09/2016. In spite of no case has been started uptill. On the other hand the accused persons are threatening the complainant and her family members. Such being situation the complainant has no alternative but to take shelter of Ld. Court of Law.

Hence it is prayed to pass an order directing the O/C, Kolaghat P.S. to treat this complaint as an F.I.R. U/S- 156(3) Cr.P.C. and to investigate in accordance with Law.
