Sir,

In producing herewith one arrested accused person namely Nimai Bhoumik (52) S/O It. Panchu Bhoumik of village-Brindabanchak, P.S.Panskura, District-Purba Medinipur and also seized 05(Five) Ltrs. I/D liquor in a Jar-cane, I ASI Suman Banerjee do hereby lodged a written complaint against the above noted accused, to the effect that today on (14.01.17) during my Special mobile raid duty vide Kolaghat B/H GDE no. 346 dt. 14.01.17 received a source information at 17:15 hrs that someone is selling I/D Liquor at a temporary shop at Khanyadihi. After a short while to work out the information myself along C/1000 Balai Chand Murmu and NVF Tapas Khamrui vide Kolaghat B/H CCno-54/17, Dated 14/01/17 reached at Khanyadihi at 18:05 hrs and found the above noted person is selling I/D liquor at his temporary shop at Khanyadihi with a medium size Jar-cane. Seeing police party the customers flee away but we apprehend the seller namely Nimai Bhoumik (52) S/O It. Panchu Bhoumik of village-Brindabanchak, P.S.Panskura, District- Purba Medinipur. Accordingly myself along with forces detained the said person and asked about the any valid documents or license of the said liquor contained in Jar-cane. On our interrogation the said person confessed that he is running his business since few months ago without any license or valid documents and the liquor contain in the jar cane is I/D liquor. Then I asked the local people to accompany us for search. But none could come forward. So, in presence of police witnesses search the temporary shop and seized.

1)One Jar-cane containing 05 (Five) Ltrs I/D liquor worth RS 200/- (05X40/-=Rs 200/-) [Approximate]

under proper seizure list and duly signed by the police witnesses who were with me and labeled it. I also extracted one (01) Ltr I/D liquor in a bottle from seized articles SL No-1 as test sample. I arrested Nimai Bhoumik (52) S/O It. Panchu Bhoumik of village-Brindabanchak, P.S.Panskura, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling I/D liquor illegally, maintaining all norms of honourable Apex court. Searched him well but found nothing without his W/A. The accused has been rendered all sorts of facilities as per guideline of Law.

Hence, I pray a cog case may kindly be started against the accused namely Nimai Bhoumik (52) S/O It. Panchu Bhoumik of village-Brindabanchak, P.S.Panskura, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
