Sub: Complaint

In producing here with arrested accused person namely Sourish Dey (Age 46 Yrs) S/o Arun Prasad Dev of Kantapukur, Laxmipur, PS- Burdwan, Dist- Purba Bardhaman and seized one improvised Single barrel pipe gun length about 9 inches having butt, body, barrel, trigger, firing pin etc three round of .12 bore ammunition and others voter Identity Card, black colour school bag along with original seizure list, memo of arrest etc, I Sri Soumik Sengupta, SDPO (S), South, Burdwan, Dist- Purba Bardhaman do hereby lodged this complaint to the effect that on 22.04.17 at 18.15 hrs I received credible source information that the above noted accused person may be stay in a hotel namely hotel Maharaj at Kolaghat with his other friends. It is to be noted that the said person is wanted and absconded in c/w Burdwan P.S. Case No- 331/17 dt- 31/03/17 u/s-447/186/353/384/ 354C/506/34 IPC and 3(1)(IX)(X) of The Schedule Caste & The Schedule Tribe (Prevention of Atrocities) Act, 1989. On getting this information I directed ASI Madhu Sudan Samanta, Duty Officer of Burdwan P.S. over telephone to lodge a General Diary regarding this information. Accordingly ASI Madhu Sudan Samanta diarized the matter vide Burdwan PS GDE No- 1941 dated 22.04.17 and informed me accordingly. I also informed the matter to I/C Burdwan P.S and asked him to depute an officer to accompany with him for conducting raid.

Acting upon such source information I along with SI Arun Kr. Banerjee and accompany force all of Burdwan P.S proceeded to Kolaghat under PS Kolaghat on 22.04.17 at 23.25.hrs for holding raid at the said hotel to arrest above accused person. On 23.04.17 at 03.05 hrs on arrival there I along with my accompany officer and force held raid in the above hotel and some other nearby hotels and arrested the above accused person in the said hotel on 23.04.17 at 03.45 hrs. in c/w Burdwan P.S. Case No- 331/17 dt- 31/03/17 u/s- 447/186/353/384/354C/506/34 IPC and 3(1)(IX)(X) of The Schedule Caste & The Schedule Tribe (Prevention of Atrocities) Act, 1989 being issued Memo of arrest after

observing all the legal formalities. After arrest in compliance with procedure of search I conducted routine search of his person and his all belongings. During search of his personal belongings i.e. one old used black colour school bag and above mention arms loaded with 01 round ammunition and two round of .12 bore ammunition were recovered by chance. I unloaded the ammunition from above mention arms and found that the said ammunition is .12 bore ammunition. I became astonish as because no such information but after noticed it. I asked himto produce license/authority in respect of above arms and ammunitions but he failed to produce any valid license/authority in respect of above arms and The above noted accused person confessed that he procured ammunitions. the said Arms and ammunition by illegal means and carrying the same for his personal safety and security. So, he committed an offence u/s- 25(1B)(a)/27 Arms Act. So, I seized above arms, ammunition from his possessed bag as well as his possession under proper seizure list in between 04.15 hrs. and 04.30 hrs duly signed by the accused person and witnesses. Label were also prepared and pasted on respective arms and ammunitions. I also arrested him being issued Memo of arrest at 03.45.hrs in c/w Burdwan PS GDE No. 1941 dated 22.04.17 as he committed an offence u/s- 25(1B)(a)/27 Arms Act.

I request you that a case U/s- 25(1B)(a)/27 Arms Act may be started against arrested accd person namely Sourish Dey (Age 46 Yrs) S/o Arun Prasad Dey of Kantapukur, Laxmipur, PS- Burdwan, Dist- Purba Bardhaman and arrange for its investigation as the above arms and ammunitions are not related to above specific case.
