Sir,

In producing herewith one arrested male accused person namely Somnath Sahoo (32 Years) S/O Mritunjoy Sahoo of village Chouddachuli, PS Khejuri, District- Purba Medinipur and seized medium Jar-cane containing 05 (Five) Ltrs I/D liquor. I, ASI Debasish Maity do hereby lodged a written complain against the above noted accused person that on 01.06.17 evening mobile duty while myself along with forces namely C/1292 Gurupada Baj LC/1472 Sujata Patra vide Khejuri PS GDE No- 24 & C.C No- 119/17 both of date. 01.06.17 were reached at Haludbari. I received an information from a reliable source on 01.06.17 at 19.25 hrs regarding selling of illegal I/D liquor at his stationary shop at Chouddachuli near at Haludbari High School under Khejuri P.S. Then myself along with force rushed at Chouddachuli to work out the information. After a short period we reached at Chouddachuli and found the above noted person is selling I/D liquor from his said stationary shop with a medium size Jar-cane. Seeing police party the customars fled away but after prolong chassing we were able to apprehend the seller namely Somnath Sahoo (32 Years) S/O Mritunjoy Sahoo of village Chouddachuli, PS Khejuri, District- Purba Medinipur. Accordingly myself along with forces detained the said person and asked about license of any liquor for selling. But he failed to give any answer. Then I asked the local people to accompany us for search but none came forward to put signature in seizure list. Hence I seized the following articles in presence of our police team which were found from the possession of the above noted accused, under proper seizure list and duly signed police constables present with me. I also labeled the seized item. On 01.06.17 in between 19.55 hrs to 20.10 hrs I arrested Somnath Sahoo (32 Years) S/O Mritunjoy Sahoo of village Chouddachuli, PS Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally maintaing all norms of apex court.

1. One medium Jar-cane containing (Five) Ltrs I/D liquor (40 X 05) = 200/-.

One plastic bottle containing one (01) Ltrs. I/D liquor which was extracted from seized articles SL No-1 as test sample.

Hence, I pray a cog case may kindly be started against the male accused person namely Somnath Sahoo (32 Years) S/O Mritunjoy Sahoo of village Chouddachuli, PS Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
