Sir,

In producing herewith one arrested accused person namely Uttam Mondal (27) S/O Subal Mondal of village Baratata, P.S- Khejuri, District- Purba Medinipur and also seized ID liquor, country liquors and foreign liquor, I PSI Somnath Shit do hereby lodged a written complaint against the above noted accused to the effect that today on (03.06.17) during my evening mobile duty vide Khejuri P.S GDE no. 105 dt. 03.06.17 and P.S C.C no 1186/17 dt. 03.06.17 when I reached at Ramchak than I received an information from reliable source that someone is selling ID liquor, country liquors and foreign liquor at his house at Baratata. Thereafter, myself along with force C/1372 Chunaram Soren, LC/ 687 Manisha Midya and 03 civic volunteers left for Baratata to work out the information. After a short period while we reached at Baratata about 21.25 hrs and found the above noted person is selling id liquor, country liquors and foreign liquor at the said place. Seeing police party the customers fled away but we apprehend the seller namely Uttam Mondal (27) S/O Subal Mondal of village Baratata, P.S- Khejuri, District- Purba Medinipur. Accordingly myself along with forces detained the said person and asked about the any valid documents and license of the said liquors. But he could not able to give any satisfactory answer. Then I asked the local people to accompany us for search and in presence of witnesses search at the nearest area on the possession of accused Uttam Mondal (27) S/O Subal Mondal of village Baratata, P.S- Khejuri, District- Purba Medinipur and seized ID liquor, country liquors and foreign liquor under proper seizure list and duly signed by the witnesses and labeled its and on 03.06.17 at 21.45 hrs I arrested namely Uttam Mondal (27) S/O Subal of village Baratata, P.S- Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally maintaing all norms of honourable apex court.

**Description of the seized items**

- i) Two Jar-cane containing (10 Ltrs. X 2) = 20 [twenty] Ltrs 1/D liquor (20 X 50) = worth Rs.- 1,000/-
- ii) Bindash Country Sprit 20 Pieces (600 ml.) X Rs 65 = worth Rs. 1,300/-
- iii) Mc Dowell's XXX Rum 05 (five) pieces (375 ml) Rs. 180/- = worth Rs. 900/- total Rs. 3,200/-

One plastic bottle containing one (01) Ltrs. 1/D liquor, One bottle Bindash Country Sprit (600 ml.) & one Mc Dowell's XXX Rum (375 ml) which was extracted from seized articles SL No-1 to 3 as test sample.

Hence, I pray a cog. case may kindly be started against the namely Uttam Mondal (27) S/O Subal Mondal of village Baratata, P.S- Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
