Sir,

In producing herewith one arrested female accused person namely Parul Bala Mondal (40) W/O Jhantu Mondal of village Sahapur, PS Khejuri, District- Purba Medinipur and seized one 05 (Five) Ltrs. Jar-cane containing 05 (Five) Ltrs I/D liquor. I, SI Bibhas Dolai do hereby lodged a written complaint against the above noted accused person that on 16.01.17 evening mobile duty while myself along with forces namely C/06 Sasdhar Das, HG/4400100 Digbijoy Mondal & LCVF/344 Chaitali Datta vide Khejuri PS GDE No- 800 & C.C No - 116/17 both of dated 16.01.17 were reached at Vidyapith more. I received an information from a reliable source on 16.01.17 at 16.30 hrs regarding selling of illegal I/D liquor at his temporary shop at Vidyapith more. Then myself along with force rushed at Vidyapith more to work out the information. After a short period we reached at Vidyapith more and found the above noted person is selling I/D liquor from her said temporary shop with a medium size Jar-cane. Seeing police party the customers fled away but after prolong chasing we were able to apprehend the seller namely Parul Bala Mondal (40) W/O Jhantu Mondal of village Sahapur, PS Khejuri, District- Purba Medinipur. Accordingly myself along with forces detained the said person and asked about license of any liquor for selling. But she failed to give any answer. Then I asked the local people to accompany us for search but none came forward to put signature in seizure list. Hence I seized the following articles in presence of our police team which were found from the possession of the above noted accused, under proper seizure list and duly signed police constables present with me. I also labeled the seized item and on 16.01.17 at 17.15 hrs I arrested Parul Bala Mondal (40) W/O Jhantu Mondal of village Sahapur, PS Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally maintain all norms of apex court.

1. One 05 (Five) Ltrs. Jar-cane containing 05 (Five) Ltrs I/D liquor (40 X 05) = Worth Rs. 200/-.

One plastic bottle containing one (01) Ltrs. I/D liquor which was extracted from seized articles SL No-1 as test sample.

Hence, I pray a cog case may kindly be started against the accused persons namely Parul Bala Mondal (40) W/O Jhantu Mondal of village Sahapur, PS Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
