Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Nimai Das, S/O- Niranjan Das of Vill+PO- Chouddachuli, P.S- Khejuri, Dist-Purba Midnapur for commission of theft in respect of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 24.01.2017 at about 12:50 PM, I, Sri Prashanta Biswal, A.E. & S.M. Khejuri CCC along with Sri Sourabh Santara, SAE, Khejuri CCC, Sri Subrata Das, TSH of Khejuri CCC and other officials had been to the Village- Chouddachuli for inspection purpose of energy meters in connection with Agricultural purpose. Accordingly we arrived at Vill- Chouddachuli in the Agriculture field of one Nimai Das S/O- Niranjan Das, and He is a permanent STW Consumer with Consumer Id. No- 201960577 and Meter no- GX026508. During inspection it was found that the said Nimai Das S/O- Niranjan Das was consuming electricity unauthorizedly by way of direct hooking for less recording of energy units into his meter from nearest resource resulting loss of revenue to WBSEDCL at the tune of load of 4.38 KVA.

As theft of electricity was detected during the inspection, we disconnected the service line there after some portion of 3 nos. of hooking cables, Single core Black colored PVC coated cable of 6 Sqmm 2 Metres (approx.) each were seized under a memo of a seizure list in the presence of the witnesses and their signature also obtained on the seizure list. Thereafter the seized articles were packed and labeled at the inspection site and signature of witnesses obtained on the packed label. After completion of inspection the inspection team left the aforesaid premises at 01:30 PM.

Thus Nimai Das S/O- Niranjan Das of Vill+PO- Chouddachuli, P.S- Khejuri, Dist-Purba Midnapur has committed an offence u/s 135 (1) (a) of the Electricity Act 2003 read with Amendment Act 2007. So you are requested to take cognizance of this complain & treat it as FIR.


