In producing herewith one arrested accused person namely Apurba Mondal @ Bapi (35) S/O Kanailal Mondal of village Kadirpur, P.S. Khejuri, District- Purba Medinipur and also seized 05 (Five) Ltrs. I/D liquor in a Jar-cane, I SI Joygopal Barai do hereby lodged a written complaint against the above noted accused to the effect that today on (28.01.17) during my evening mobile duty vide Khejuri P.S GDE no. 1310 dt. 28.01.17 and P.S C.C no 213/17 dt. 28.01.17 when I was at Kadirpur village under Khejuri P.S received a source information that someone is selling ID Liquor on the Road side of Kadirpur, myself along with force C/994 Gourhari Gayen, HG/4400100 Digbijoy Mondal left for Kadirpur to work out the information. After a short while we reached at Kadirpur about 20.05 hrs and found the above noted person is selling I/D liquor on the Road side at said place with a medium size Jar-cane. Seeing police party the customars fled away but we apprehend the seller namely Apurba Mondal @ Bapi (35) S/O Kanailal Mondal of village Kadirpur, P.S. Khejuri, District- Purba Medinipur. Accordingly myself along with forces detained the said person and asked about the any valid documents and license of the said liquor contained in Jar-cane. But he could not able to give any satisfactory answer. Then I asked the local people to accompany us for search and in presence of witnesses search on the house of accused Apurba Mondal @ Bapi (35) at Kadirpur village and seized 05 (Five) Ltrs I/D liquor in a medium Jar-cane under proper seizure list and duly signed by the witnesses and labeled its and I arrested namely Apurba Mondal @ Bapi (35) S/O Kanailal Mondal of village Kadirpur, P.S. Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally maintaing all norms of honourable apex court.

1) One Jar-cane containing 05 (Five) Ltrs I/D liquor worth. (05 X 50) = 250/-)

One plastic bottle containing one (01) Ltrs. I/D liquor which was extracted from seized articles SL No-1 as test sample.

Hence, I pray a cog case may kindly be started against the namely Apurba Mondal @ Bapi (35) S/O Kanailal Mondal of village Kadirpur, P.S. Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 and arrange for its investigation.
