Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Saktipada Bhunia, S/O - Lt. Bankim chandra Bhunia of Vill- Shyamchak, P.O- Heria, P.S- Khejuri, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 13.02.2017 at about 11:40 AM I, Sri Prashanta Biswal, AE & SM Khejuri CCC along with Sri Sourabh Santara, SAE and Sagar Kandar LM, Khejuri CCC and others had been to the Village- Shyamchak for routine inspection purpose. During inspection it was found that Sri Saktipada Bhunia was consuming electricity dishonestly in his Agricultural (STW) premises unauthorisedly by the way of direct hooking from the nearby LTOH line causing loss of revenue of WBSEDCL to the tune of load 4.38 KVA.

As theft of electricity was detected during inspection, the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 3 (three) nos of separated single core 6 Sq mm 1 (one) Black and other 2 (two) nos. wheatish brown colour PVC coated aluminium conductor of length 2 (two) meters each approx along with hooking device used to run the agricultural pump unauthorisedly for agricultural purpose were seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 12:20 PM.

Thus the accused Sri Saktipada Bhunia, S/O - Lt. Bankim chandra Bhunia of Vill- Shyamchak, P.O- Heria, P.S- Khejuri, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
