Dear Sir,

I do hereby lodge written complaint empowered by the electricity Act 2003, read with amendment act 2007, to the effect that Sri Nikhil Patra s/o Sri Pravat Kr Patra, a permanent resident of village - Tangramarci, Po - Janka, Ps. Khejuri, Dist. Purba Medinipur, committed theft of electricity u/s 135 of the electricity act 2003 read with amendment act 2007, as stated here under.

On 20.02.17 at about 02:45 PM I, Sri Manas Maity, AE(U), SLP, Sri, Pradip Kr Chakraborty, SO, SLP, both are of Centai Division Office along with Sri Sourabh Santara, SAE(E), Sri Gokul Ch. Mandal Ag. Sr. LM both are of Khejuri Customer Care Centre, had been to the village Tangramarci, Po - Janka, Ps. Khejuri Dist - Purba Medinipur for routine inspection purpose, and found that Sri Nikhil Patra s/o Sri Pravat Kr. Patra was consuming electricity dishonestly by the way of direct hooking through 2 core round shape, black colour PVC coated 6 sqmm aluminium conductors of ~~length~~ from the nearby LT mains of WBSEDCL unauthorisely, to run the electrical pump motor (STM) set for agricultural purpose, causing considerable loss of revenue of WBSEDCL to the tune of load 1.76 kVA.

As theft of electricity was detected during inspection the illegal hooking line was dismantled and some portion of 2 core round shape black colour PVC coated 6 sqmm aluminium conductors of length 2 (two) meter approx along with hooking device were seized after removal of the same. Under memo of seizure list in presence of witnesses and their signature were also duly obtained in the seizure list, and representative of the accused.
