Sub: - Declaration of lodging complain against the aced. Persons mentioned below.

Sir,

I, the undersigned, being the Teacher-in-charge of "Tikashi Kshirod Chandra Balika Vidyalaya" under khejuri P.S. do hereby lodge complain against the below scheduled persons for their serious offences.

The aced. No. 1 was the previous Head Mistress of this institution who has retired from her service on 31.12.2016 and aced. No. 2 is her husband.

The aced. No. 1 in association with her husband has misappropriated a huge amount of public money as well as govt. property from 2008 to 2016. During this period she was doing such misappropriation of public money only for their own interest with cool head by enjoying the power of her chair as Head Mistress of this school. They were also causing disappearance of evidence of offence by damaging/destroying various valuable documents of this institution such as library fund register, development fund register, "Sarba Siksha Adhijan" fund register, deed of the institution, resolution books and many other valuable registers with the intention of screening their offence from legal punishment. The aced. No. 1 was also requested repeatedly by the Teacher-in-charge of "Tikashi Kshirod Chandra Balika Vidyalaya" to submit the concerning documents but she had not. She was the sole keeper of all documents of this institution. All the essential documents are required to be discovered.

All these heinous offences of the aced. Persons will be established from this school authority as well as from the staff at the time of investigation of this complain.

Under the circumstances stated above it is crystal clear that the aced. Persons have cheated this institution and misappropriated public money by way of preparation and submission several falsified papers/ documents of this school and all the illegal work were done by them with criminal conspiracy according to their own wishes.

So, you are therefore requested to start a case by treating this complain of FIR u/s 409/420/406/447(A)/201 etc. of the I.P.C. against the aced. Persons and investigate properly for the interest of public, govt. as well as the natural justice.


