In producing herewith three (3) arrested accused namely 1)Sk. Hammed(38) @ Ghonga@ Habi S/O Sk. Aktar of Sherkhanchak PS- Khejuri, 2) Sk Sabbir (21) S/O Sijabuddin of Sherkhanchak PS Khejuri 3) Sunil Sau @ Langra Bapi (36) S/O Lt Radha Krishna of Kayem garia PS- Bhupatinagar and seized articles along with seizure list and labels 1) one shooter pipe gun length about 9 inch. Wooden butt, fitted with firing pin, hammer 2) two live 303 bullet 3) tow motorcycles one Bajaj Discover and One Super Splendar 4) 15 old Rs 1000/- fake currencies. 5) one dagger measuring 1.5 ft approx. 6) one iron rod measuring 3 ft. approx I S.I. Joygopal Barai of Khejuri P.S, do hereby lodge this complaint as Suo- Moto against above noted three arrested accused persons and another 4) Sk. Maju Ali Saha S/O Sk. Manilai Saha of Maldha P.S. Khejuri 5) Mir Usman Ali @ Ara S/O Mir Durlop Ali Vill- Maldha P.S. Khejuri and one unknown (not arrested) all of Dist-Purba Medinipur, to the effect that on the night 26/27-03/17 at about 23:25 hrs myself received a secret source information from my reliable source that the above noted three arrested accds person with 3 /4 others persons being armed with lethal weapons will assemble at Irrinchi site to commit dacoity or robbery on any passing bus or vehicle from and within 00:30 to 01:30 hrs under Khejuri PS. I informed the matter to O/C Khejuri PS. This fact was entered in GDE vide GDE No of Khejuri PS 1452 /17 DT 26/03/17 and as per his instruction myself scrambled available force and officers vide CC No 659/17 DT 26/03/17 and left for PO with force namely 1)ASI Sourav Praharaj 2) ASI Debasish Maity 3) C-1132 Samar Das 4) C-994 Gourhari Gayan 5) C-1365 Subrata Bera 6) C-1372 Chunaram Soren vide GDE No 1453/17 Dt 26/03/17 and also directed night mobile under ASI Dipankar. Saha to remain present at Kalagachia Site to accompany from there for Irrinchi site as per the order of O/C khejuri PS and earlier he had left for night mobile vide GDE NO 1448/17 dated 26/04/17 and left for Irrinchi site to work out the said information on Govt Vehicle bearing No WB 30 B 7280(DP) at 23:45 hrs. When we reached at Irrinchi site at about more at 00:25 hrs on 27/03/17 and left our vehicle before irrinchi bridge and kept ourselves in ambush just crossing the bridge in the nearby thick vegetation along the road. Soon at about 00:45 hrs. two motorcycles arrived on which 6 persons were there and they stopped just few meters ahead of us. They alighted and in the light of the roads and passing vehicle we could they were armed to their tooth and nails. They immediately started to place boulders on roads to block night service bus and commit dacoity. We stealthily veer close to them and before we could take them on gun point they all took to their heels. We chased and managed to arrest 3 accused persons. They gave their names when I interrogated them and confessed that all six of them have assembled there with arms to commit bus dacoity. I searched their persons observing all formalities and beforehand I had asked them to search me and my party if the desire but they decline. I found following aricles 1) one shooter pipe gun length about 9 inch. Wooden butt, fitted with firing pin, hammer from Sk. Hammed(38) @ Ghonga@ Habi S/O Sk. Aktar of Sherkhanchak PS- Khejuri, Dist. Purba Medinipur measuring 09 Inch. in length tucked in side pant along the left side of his waist having butt barrel firing pin trigger and one .303 live round in the right pocket of his pants shown and produced by him and seized from his exclusive possession. 2) one dagger seized from the exclusive possession of Sunil Sau @ Langra Bapi (36) S/O Lt Radha Krishna of Kayem garia PS- Bhupatinagar as shown and produced by him 3) One iron road from the exclusive possession of Sunil Sau @ Langra Bapi and one live cartridges of .303 from his right side pant's pockets Sunil Sau @ Langra Bapi S/O Lt Radha Krishna OF Kayem Garia PS Bhupatinagar as shown and produced by him during search and seizure. This sized was done from 01:05 to 01:25 hrs. They also confess that those two motorcycles on which they came belong to Sk. Hammed(38) @ Ghonga@ Habi and Sunil Sau @ Langra Bapi (36) S/O Lt Radha Krishna.

I searched those two motorcycles both without any number plate seized them in the presence of accused at the PO with help of Police team as witness as it was difficult to find any witnesses there at

such awe hours of night. One Bajaj Discover motorcycles having engine no JBUBSG57657and chasis No.MD2DSPAZ7SPG71816 said to be owned by Sk. Hammed (38) @ Ghonga@ Habi was searched and from its dicky some old Rs 1000/- Indian currencies denomination were found. They were 15 in numbers having serial numbers 1)6DK 548596 2)6DK 548597 3)6DK 548598 4) 6DK 548599 5)6DK 548600 66DK 544402 7. 6DK 544404 8.6DK 544406 9. 6DK 544407 10. 6DK 544410 11. 6DK 544412 12. 6DK 544416 13. 6DK 544417 14. 6DK 544418 15. 6DK 544421 being asked he said that earlier he used to deal in them and had procured months back and I had asked him to sign on them on each fake currencies and he put his signature on them and the witnesses and me also signed on them. I seized them under proper seizure list. This sized was done from 01:40 to 02:05 hrs. I also searched another motorcycle styled as Super Splendar said to be owned by Sunil Sau @ Langra Bapi (36) S/O Lt Radha Krishna and found nothing in that Motor cycle having engine numberJA05EA99MO7593.and chassis number BMLIAO5EE99MO7988. This sized was done from 02:15 to 02:25 hrs. in all three seizure lists signature of witnesses and accused were taken and label too were signed by witnesses and accused at the PO and me also signed in their presence at PO. the said accused moving suspiciously at Shyampur more. I again then interrogated them properly and ask to produce any valid license or any valid documents in supports of possession of said fire arms and ammunition Motor Cycles. But they failed to produce any document and they also confessed that they had assembled to commit dacoity with deadly weapons and those motorcycles had been acquired by them fraudulently.

During raid I discovered that a Sunil Sau @ Langra Bapi (36) S/O Lt Radha Krishna of Kayem garia PS- Bhupatinagar hade one bandage wrapped around his ankle. I asked him about that bandage and injury his state that he had sustained one cut injury a fue days that and he is treated from Hospital stitches were given by doctor. I extended meical and legail aeids to all accd persons to which dad a clamed I had also in formed them the cosed and ground of thir arrest and informed their relatives and furnished memo of arrest.

Then I seized the said arms and ammunition in presence of above mention witnesses after preparing proper seizure list duly signed by them, also labeled the seized article and marked as Exhibit: A- one shooter pipe gun length about 9 inch. Wooden butt, fitted with firing pin, hammer, Exhibit: B-1 and B-2 Two .303 live cartridge. Dagger as Exhibit C- measuring 1.5 ft. Exhibit D- 3ft long iron rod. Exhibit E- 15 (fifteen) fake currencies note of old Rs 1000. Exhibit F- Bajaj Discover motorcycles. Exhibit G- Super splendor Motorcycle.

As the said accused failed to produce any valid documents for possession of above seized arms and ammunition Fake currencies Motor Cycles had assembled on Irrinchi on NH 116 B at night hours and placed boulders on road to commit bus dacoity their acts are punishable 399/402/489 B/489 C IPC and-25(1)(a)/27 Arms act 1959. So I lodged this Suo Moto complaint against above noted accused person.

Hence, I pray a case under section 399/402/489 B/489 C IPC and 25(1)(a)/27 Arms Act, 1959 may be started against the accused 1)Sk. Hammed(38) @ Ghonga@ Habi S/O Sk. Aktar of Sherkhanchak PS-Khejuri, 2) Sk Sabbir (21) S/O Sijabuddin of Sherkhanchak PS-Khejuri 3) Sunil Sau @ Langra Bapi (36) S/O Lt Radha Krishna of Kayem garia PS-Bhupatinagar 4) Sk. Maju Ali Saha S/O Sk. Manilai Saha of Maldha P.S-Khejuri 5) Mir Usman Ali @ Ara S/O Mir Durlop Ali Vill-Maldha P.S-Khejuri and one unknown all of District-Purba Medinipur and arrange for it's investigation.
