Sir,

In producing herewith two arrested accused persons namely (1) Siddhartha Sankar Jana (47), S/O- Satyendranath Jana of Vill + PO- Sarpai, PS- Marishda, Dist- Purba Medinipur and (2) Pranab Kumar Mandal (30), S/O- Amalabja Mandal of Sukunia, PS- Marishda, Dist- Purba Medinipur, I ASI Saibal Maity of Heria IC under Khejuri PS do hereby lodge a complaint as Suo moto to the effect that, on 29/03/2017 - 30/03/2017 night I along with SAP C/68 Prasenjit Bar, CVF 294 Atanu Hazra, CVF 220 Parsuram Maity, CVF 164 Atanu Barik were engaged in Naka checking duty at Irinchi under Khejuri PS vide Heria IC CC No 774/17 dated 29/03/2017 and GDE No 1165 dated 29/03/2017 along with officer & forces of Bhupatinagar PS, as per order of SP Purba Medinipur. Then at 23:45 hrs one vehicle bearing registration number WB 34X 2245 was going towards Contai side from Tamluk side. I stopped the vehicle and requested the driver of the vehicle to produce papers relating to the vehicle as we are performing naka checking duty at Irinchi. The driver refused to show any papers and even challenged the legality of demanding papers from him by a police officer and suddenly drove away from Irinchi towards Marishda with rush and negligent driving. On duty police personals had to run for their life due to this rush and negligent driving by driver of vehicle bearing registration number WB 34X 2245. In the mean time OC Khejuri PS also had reached at the spot and witnessed the scenario. I at once contacted with night mobile officer of Heria IC, ASI Utpal Chakraborty, who was at Kalamdan during night mobile duty at that time, to restrain the vehicle bearing registration number WB 34X 2245 going towards them. Myself along with OC Khejuri PS and forces also rushed behind the vehicle to restrain the vehicle. Near Dakshin Kalamdan Petrol pump with the help of night mobile duty party we managed to stop the vehicle bearing registration number WB 34X 2245 again at 23:50 hrs. After that we again demanded vehicle related papers but the driver again refused to show any papers of the vehicle. On interrogation name of the driver is learnt as Siddhartha Sankar Jana (47), S/O- Satyendranath Jana of Vill + PO- Sarpai, PS- Marishda, Dist- Purba Medinipur. In the mean time one person namely Pranab Kumar Mandal (30), S/O- Amalabja Mandal of Sukunia, PS- Marishda, Dist- Purba Medinipur came at the spot i.e. near Dakshin Kalamdan Petrol Pump and both, the driver and Pranab Mandal, started misbehaving with on duty police personals including OC Khejuri PS. The person identified himself as constable of West Bengal Police posted at Shibpur police line, Howrah bearing brush number C/2447 under Howrah Police Commissionerate. He prevented on duty police personal from performing Govt. duty and also restrained police at that place. Myself and OC Khejuri PS requested Pranab Mandal to leave the place and let police do their job, but they became furious and physically assaulted C/06 Sasadhar Das and CVF 63 Amit Das both of Khejuri PS and they became severally injured. Finding no other alternative I arrested the driver namely Siddhartha Sankar Jana (47), S/O- Satyendranath Jana of Vill + PO- Sarpai, PS- Marishda, Dist- Purba Medinipur and Pranab Kumar Mandal (30), S/O- Amalabja Mandal of Sukunia, PS- Marishda, Dist- Purba Medinipur at 00:15 hrs and seized the vehicle bearing registration number WB 34X 2245 and driving licence of the driver preparing proper seizure list and label. Injured police personals are treated at Heria PHC. Arrested accused persons were also treated at Heria PHC.

Under the above, I therefore pray before you that a specific case may kindly be started against two arrested accused persons namely (1) Siddhartha Sankar Jana, S/O- Satyendranath Jana of Vill + PO- Sarpai, PS- Marishda, Dist- Purba Medinipur and (2) Pranab Kumar Mandal (30), S/O- Amalabja Mandal of Sukunia, PS- Marishda, Dist- Purba Medinipur under section 279 / 186 / 187 / 341 / 332 / 353 / 34 IPC & 183 / 184 MV Act.
