In producing herewith one arrested accused person namely Snehasish Maity (32) S/O Lt Amulya of village Deulpota, P.S- Khejuri, District- Purba Medinipur and also seized 20 (Twenty) Ltrs. I/D liquor in two 10 Ltes. Jar-cane, I PSI Somnath Shit do hereby lodged a written complaint against the above noted accused to the effect that today on (17.04.17) during my evening mobile duty vide Khejuri P.S GDE no. 688 dt. 17.04.17 and P.S C.C no 845/17 dt. 17.04.17 when I reached at Kamarda Bazar than I received an information from PS that someone is selling ID Liquor on the road side of Deulpota. Thereafter, myself along with force C/1372 Churnaram Soren and 03 civic volunteers left for Deulpota to work out the information. After a short period while we reached at Deulpota about 21.45 hrs and found the above noted person is selling I/D liquor on the road side at that village with a Jar-cane. Seeing police party the customars fled away but we apprehend the seller namely Snehasish Maity (32) S/O Lt Amulya of village Deulpota, P.S- Khejuri, District- Purba Medinipur. Accordingly myself along with forces detained the said person and asked about the any valid documents and license of the said liquor contained in Jar-cane. But he could not able to give any satisfactory answer. Then I asked the local people to accompany us for search and in presence of witnesses search at the nearest area on the possession of accused Snehasish Maity (32) S/O Lt Amulya of village Deulpota, P.S- Khejuri, District- Purba Medinipur at Deulpota village and seized 20 (twenty) Ltrs I/D liquor in two 10 Ltes. Jar-cane under proper seizure list and duly signed by the witnesses and labeled its and I arrested namely Snehasish Maity (32) S/O Lt Amulya of village Deulpota, P.S- Khejuri, District- Purba Medinipur u/s 46 A (C) of Bengal Excise Act 1909 for selling ID liquor illegally maintaing all norms of honourable apex court.
