Sir,

In producing here with one 01 plastic jar containing about 10 liters of ID liquor and one liter of ID liquor taken from the plastic jar cane in one plastic bottle as sample, I ASI Dibyendu Biswas, presently posted at Heria IC under Khejuri PS, do hereby lodge a complaint as Suo-moto to the effect that, today (15/05/2017) at about 19:30 hrs myself received an information from one of my reliable source during my evening mobile duty that, one person named Shyamal Baunia is selling ID Liquor illegally at Tikashi village under Khejuri PS. At once myself informed the matter to In Charge of Heria IC and as per his instruction myself along with CVF/-163 Santu Barik, CVF/-164 Atanu Barik engaged in mobile duty vide Heria IC GDE No 640 dated 15/05/2017 and CC No 1465/17 dated 15/05/2017, reached at Tikashi village at about 20:35 hrs and noticed that one person is selling ID liquor at Tikashi bazaar near Tikashi High School east side gate. Seeing police party he fled away but we found one plastic jar cane containing about 10 liters of ID liquor from the spot. I requested local people to accompany us during search & seizure but no one came forward. Then I seized the plastic jar cane containing about 10 liters of ID liquor from the spot under proper seizure list (the approx value of seized ID liquor is Rs 600/-) in presence of police witnesses, one liter of ID liquor is taken from the plastic jar cane in one plastic bottle as sample and also seized. From local people name of the accused known person as Shyamal Baunia @ Kanchu (31), S/O- Siddheswar Baunia of Vill+PO- Tikashi, PS- Khejuri, Dist- Purba Medinipur.

Under the above noted circumstances, I therefore pray that, a case may kindly be started u/s 46A(c) of B.E. Act. against the accused Shyamal Baunia @ Kanchu (31), S/O- Siddheswar Baunia of Vill+PO- Tikashi, PS- Khejuri, Dist- Purba Medinipur.
