This is to bring to your kind and urgent attention, that, approximately at 4:50 PM, on 23rd December, 2016, Near Nachunda Kali Temple, my car (Maruti Swift - WB 06K 4321) was hit from behind by a Digha bound bus (Parameshwar - WB 41G 3903), on Mecheda - Digha Pitch Road (NH-116B). It was, as usual, a crowded/busy road, My car, driven by my driver, overtook a truck, in an average speed of 30-35 km/ps we were moving during that phase. The guilty vehicle which was
