Today (21/02/17) at 14.10 hrs I SI Chandra Kanta Sasmal O/C, Marishda P.S. do here by lodged a written complaint to the effect that on 21.02.17 at 10:55 hrs received a telephonic information from B.D.O. Contai- III to remove the sand from NH 116B near Gayagiri area under Marishda P.S. and to take legal action against owner of the sand.

As per information myself along with force C/- 678 Sadet Ali Khan, C/- 973 Dilip Kr. Mahato, C/- 879 Goutam Ghosh, C/- 1669 Sekhar Gurum, LC-1254 Manisha Bera (Mondal), LC- 1708 Dipali Barik all of Marishda P.S. went to the spot. This refers Marishda P.S. GDE no. 875 date- 21.02.17. I found huge quantity sand were gathered there by half portion covered NH 116B road near Gayagiri under my P.S. jurisdiction. It is seen that vehicular traffic has come to a halt on this important busy NH road which leads to Digha. It is also learnt that heap of sand has kept by one contractor namely Tapan Bera s/o Lt. Gouranga Bera of Alampur, P.S.- Marishda, Dist- Purba Medinipur for construction work of nearby village road

With the help of accompanying of police personnel and local people and also labours with tractor, JCP removed the heap of sand and started free flow of traffic again on the NH 116B (400 CFt sand approx) that the cause road obstruction materials has been seized from the spot under proper seizure list in presence of BDO Contai -III Md Nur Alam, WBCS during removal of sand and brought to P.S. I tried to arrest the owner of sand namely Tapan Bera but could not be available

Hence I started Marishda PS specific case no- 20/17 dt 21/02/17 u/s- 283/290 IPC & 8(B) NH Act. against Tapan Bera s/o Lt. Gouranga Bera of vill- Alampur, P.S.- Marishda, Dist- Purba Medinipur. and PSI Pralay Kr Chandra of Marishda PS directed to investigate the case
