Sir,

In producing herewith one arrested accused person namely Sri Satyaranjan Maity aged 62 yrs. S/O Late Jibankrishna Maity of Vill.- Serpureathoribar, P.S.- Contai, Dist- Purba Medinipur with seized articles (i) 15 (Fifteen) bottles of Bindas brand country spirit each bottle containing 600 ml. and worth of Rs.55/- each, under proper seizure list, I S.I. Shantimoy Nandi of Marishda PS do hereby lodge complaint to the effect that on 11/03/17 at 14.05 hrs. myself along with C/1203 Santosh Bouri, C/1325 Gopal Sar, C/1355 Shibram Murmu left P.S. for evening mobile duty vide Marishda P.S C.C no-558/17 dtd 11/03/17 and GDE no-448 dtd. 11/03/17. During evening mobile duty at about 18:00 hrs we reached at Serpur village near Bangya Gramin Bikash Bank it is noticed that one person selling country spirit in open place. After that we held raid against the country spirit seller in open place. On getting scent arrival of police the country spirit seller tried to flee away but after chase we managed to apprehend him. On interrogation the apprehended person disclose his identity as Satyaranjan Maity aged 62 yrs. S/O Late Jibankrishna Maity of Vill.- Serpureathoribar, P.S.- Contai, Dist- Purba Medinipur. Search was made in presence witness police party and apprehended person Satyaranjan Maity and found that above noted seized articles in his position. Being asked the apprehended person Satyaranjan Maity failed to produce any valid documents, papers, license, challan etc. for possessing and selling of country spirit to public. I arrested him and informed him ground of arrest, issued memo of arrest and seized the above noted articles after preparing proper seizure list duly signed by the witnesses as well as apprehended person and took sample from the seized articles and labeled it. Total seized articles are 9 ltrs approx and cost of Rs-825/-.

Under the above backdrops I pray a cog. case may kindly be started against accused person namely Satyaranjan Maity aged 62 yrs. S/O Late Jibankrishna Maity of Vill.- Serpureathoribar, P.S.- Contai, Dist- Purba Medinipur under proper section of law.
