Sir,

I do hereby lodge a complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that Sudhangshu Mondal, S/O: Lt Amulya Mondal at village: Sukunia, P.O.: Sarpai, P.S.: Marishda, Dist: Purba Medinipur has committed theft of electricity U/S-135 of the Electricity Act-2003 read with amendment act-2007 is being stated hereunder.

On 19.04.2017 around 02:20 P.M. I, Subhendu Sarkar, A.E. & Station Manager of Marishda CCC along with Snehasish Khatua, Sr. SAE, Prasun Das, O.E, Ashok Kr Dolui, Hg. Sr.LM, and Subhas Singh, TSH belong to Marishda CCC entered the Commercial premises (Shop) of Sudhangshu Mondal, S/O: Lt Amulya Mondal at village: Sukunia, P.O.: Sarpai, P.S.: Marishda, Dist: Purba Medinipur for routine inspection and found that Sudhangshu Mondal, S/O: Lt Amulya Mondal at village: Sukunia, P.O.: Sarpai, P.S.: Marishda, Dist: Purba Medinipur was consuming electricity dishonestly by the way of direct hooking from nearest installation of WBSEDCL for less recording of meter causing revenue loss of WBSEDCL at a tune of load 1 KW. At that premises there is a connection vide consumer ID is: 200910579

As theft was detected during inspection that line has been disconnected from LT installation of WBSEDCL and some portion of one number two core black coated PVC cable (approx 1 ft in length) was seized in presence of the members of inspection team. The seizure list was prepared in presence of inspection team and obtained signatures on the seizure list. The seized material duly packed and labeled. After completion of inspection the inspection team left the aforesaid premises around 02:40 P.M.

Thus Sudhangshu Mondal, S/O: Lt Amulya Mondal at village: Sukunia, P.O.: Sarpai, P.S.: Marishda, Dist: Purba Medinipur have committed theft of electricity U/S - 135 (i)(b) of the Electricity Act 2003 read with amendment act 2007.

You are, therefore, requested to take cognizance of this offence for this complaint and treat it as F.I.R.
