In producing herewith one arrested accused person namely Rabindra Ghorai aged 45 yrs. s/o Lt. Chandra Mohan Ghorai of vill.- Kusumpur, P.S.- Marishda, Dist- Purba Medinipur with seized articles (i) 26 (Twenty Six) bottles of Sun brand country sprit each bottle containing 600 ml. and worth of Rs. 65/- each under proper seizure list, I A.S.I. Mrinmoy Bhunia of Marishda PS do hereby lodge complaint to the effect that on 10/06/17 at 14.05 hrs. myself along with C/458 Susanta Roy, C/193 Uttam Kr. Maity, C/1274 Phanibhusan Pal left P.S. for evening mobile duty vide Marishda P.S C.C no- 1462/17 dtd 10/06/17 and GDE no- 414 dtd. 10/06/17. During evening mobile duty at about 18.05 hrs. we reached at Ballavpur village it is noticed that one person selling country spirit beside Ballavpur village road. After that we held raid against the country spirit. On getting scent arrival of police the country spirit seller tried to fled away but after chase we managed to apprehended him. On interrogation the apprehended person disclose his identity as Rabindra Ghorai aged 45 yrs. s/o Lt. Chandra Mohan Ghorai of vill.- Kusumpur, P.S.- Marishda, Dist- Purba Meinipur. Search was made in presence of available witnesses, police party and apprehended person Rabindra Ghorai and found (i) 26 (Twenty Six) bottles of Sun brand country sprit each bottle containing 600 ml. and worth of Rs. 65/- each. Being asked the apprehended person Rabindra Ghorai fails to produce any valid documents, papers, license, challan etc. for possessing and selling of country spirit to public. I arrested him and inform him ground of arrest, issued memo of arrest and seized the above noted articles after preparing proper seizure list duly signed by the witnesses as well as apprehended person and took sample from the seized articles and labeled it. Total seized articles are 15.6 ltrs approx and cost of Rs - 1690/-.

Under the above backdrops I pray a cog. case may kindly be started against accused person namely Rabindra Ghorai aged 45 yrs. s/o Lt. Chandra Mohan Ghorai of vill.- Kusumpur, P.S.- Marishda, Dist- Purba Medinipur under proper section of law.
