Sir,

I do hereby lodge a complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that Bibek Maiti, S/O: Lt. Himangshu Maiti at village: Kusumpur, P.O.: Bahitrakunda, P.S.: Marishda, Dist: Purba Medinipur has committed theft of electricity U/S-135 of the Electricity Act-2003 read with amendment act-2007 is being stated hereunder.

On 15.06.2017 around 03:10 P.M. I, Subhendu Sarkar, A.E. & Station Manager of Marishda CCC along with Manas Maity, AE(U) & (S&LP) of Contai Division, WBSEDCL, and Snehasish Khatua, Sr. SAE, Prasun Das, Office Executive, Nimai Das, Sr. TSH belong to Marishda CCC entered the Commercial fishery premises of Bibek Maiti, S/O: Lt. Himangshu Maiti at village: Kusumpur, P.O.: Bahitrakunda, P.S.: Marishda, Dist: Purba Medinipur for routine inspection and found that Bibek Maiti, S/O: Lt. Himangshu Maiti at village: Kusumpur, P.O.: Bahitrakunda, P.S.: Marishda, Dist: Purba Medinipur was consuming electricity dishonestly by the way of direct hooking from nearest installation of WBSEDCL causing revenue loss of WBSEDCL at a tune of load 0.5 K.W

As theft was detected during inspection that line has been disconnected from LT installation of WBSEDCL and some portion of one number two core black coated PVC cable (approx 1.5 ft. in length) was seized in presence of the members of inspection team. The seizure list was prepared in presence of inspection team and obtained signatures on the seizure list. The seized material duly packed and labeled. After completion of inspection the inspection team left the aforesaid premises around 03:25 P.M.

Thus Bibek Maiti, S/O: Lt. Himangshu Maiti at village: Kusumpur, P.O.: Bahitrakunda, P.S.: Marishda, Dist: Purba Medinipur have committed theft of electricity U/S - 135 (i)(a) of the Electricity Act 2003 read with amendment act 2007.

You are, therefore, requested to take cognizance of this offence for this complaint and treat it as F.I.R.
