Sir,

In producing herewith one arrested accused person namely Laxman Giri aged 38 yrs. s/o Lt. Sudhir Ch. Giri of vill.- Jagudasbarh, P.S.- Marishda, Dist- Purba Medinipur with seized articles (i) 17 (Seventeen) bottles of Sun brand country spirit each bottle containing 600 ml. and worth of Rs. 65/- each (ii) 08 (Eight) bottles Haywads 5000 (BEER) each bottle containing 650 ml. and worth of Rs.- 110/- each (iii) Approx 10 (Teen) ltrs ID liquor (Cholai) in a plastic zaricane worth of Rs.- 200/- under proper seizure list, I A.S.I. Tapan Majee of Marishda PS do hereby lodge complaint to the effect that on 22/06/17 at 14.05 hrs. myself along with C/857 Bimal Kr. Maity, C/973 Dilip Kr. Mahato, C/1274 Phanibhusan Pal and L/C 1254 Manisha Bera (Mondal) left P.S. for evening mobile duty vide Marishda P.S C.C no- 1568/17 dtd 22/06/17 and GDE no- 870 dtd. 22/06/17. During evening mobile duty at about 18.45 hrs. we reached at Marishda Bazar it is noticed that one person selling country spirit, Beer, ID liquor beside road side at Marishda Bazar. After that we held raid against the country spirit, Beer and ID liquor. On getting scent arrival of police the country spirit, Beer and ID liquor seller tried to fled away but after chase we managed to apprehended him. On interrogation the apprehended person disclose his identity as noted above. Search was made in presence of available witnesses, police party and apprehended person Laxman Giri and found (i) 17 (Seventeen) bottles of Sun brand country spirit each bottle containing 600 ml. and worth of Rs. 65/- each (ii) 08 (Eight) Bottles Haywads 5000 (BEER) each bottle containing 650 ml. and worth of Rs.- 110/- each (iii) Approx 10 (Teen) ltrs ID liquor (Cholai) worth of Rs.- 200/-. Being asked the apprehended person Lazman Giri fails to produce any valid documents, papers, license, challan etc. for possessing and selling of country spirit, Beer and ID liquor to public. I arrested him and inform him ground of arrest, issued memo of arrest and seized the above noted articles after preparing proper seizure list duly signed by the witnesses as well as apprehended person and took sample from the seized articles and labeled it. Total seized articles are 25.4 ltrs approx and cost of Rs - 2,185/-. So it is crystal clear that Laxman Giri illegally selling country spirit, Beer and ID liquor to the public.

Under the above backdrops I pray a cog. case may kindly be started against accused person namely Laxman Giri aged 38 yrs. s/o Lt. Sudhir Ch. Giri of vill.- Jagudasbarh, P.S.- Marishda, Dist- Purba Medinipur under proper section of law.
