In producing herewith the following arrested accused persons namely- (i) Sk. Saheb (27 yrs.), s/o- Sk. Sahadat Ali, Vill.- Dhusia, P.S- Chandipur, Dist.- Purba Medinipur, (ii) Sk. Sajet Ali @ Sk. Takji (29 yrs.), s/o- Lt. Sk. Amiruddin, Vill.- Babua, P.S- Chandipur, Dist.- Purba Medinipur, (iii) Sk. Alamgir @ Babba (26 yrs.), s/o- Lt. Sk. Fajlu Rahaman, Vill.- Dhusia, P.S- Chandipur, Dist.- Purba Medinipur under proper memo of arrest along with following seized articles- i) One sharp knife approx 8 inches length recovered from the possession of accused Sk. Saheb, ii) One cycle chain length about 3 feet recovered from the possession of another accused Sk. Sajet Ali @ Sk. Takji, iii) One iron rod length about 3 feet from the possession of accused Sk. Alamgir @ Babba, iv) Few pieces of big boulders, v) One pair of Chappal left by one of the accused fled away were recovered from the P.O, I, ASI, Syed Abdul Mabud of Mahishadal P.S do hereby lodge a written complaint against above noted accused persons to the effect that on 10.04.17 at 00:45 hrs during my night patrolling duty vide C.C No.- 1300, dated 10.04.17 received a telephonic information from reliable source that some unknown persons has been assembled near Madhyahingli bus stand beside Teropekhy more to Kapaseria pitch road for committing any heinous road crime. Immediately I informed the matter to duty officer. Accordingly he diarized the information in General Diary vide Mahishadal PS GDE No.- 421, dated 11.04.17 and informed to O/C Mahishadal PS. As per direction of O/C Mahishadal P.S myself along with C/919, Rathindranath De Dalal and C/1582, Sandip Nayek left to the P.O to work out the information. At about 01:15 hrs on reaching near the P.O found some persons were assembled beside Teropekhy more to Kapaseria pitch road near Madhyahingli Bus Stand after obstructing the pitch road with the help of few big boulders and two motor cycles are standing there. So as per briefing myself along with force cordoned the said area and advanced towards them. On seeing police party the above noted persons and their associates tried to flee away but the police team managed to apprehend above noted three persons though rest were managed to escape riding on motor cycles. After apprehension I conducted search with their body and recovered i) One sharp knife approx 8 inches length kept with the waist of accused Sk. Saheb, ii) One cycle chain length about 3 feet kept in waist of another accused Sk. Sajet Ali @ Sk. Takji, iii) One iron rod length about 3 feet from the possession of accused Sk. Alamgir @ Babba respectively and all the articles were seized by me under proper seizure list duly signed by the witnesses. On interrogation they disclosed their name and identity as noted above. On thorough interrogation the above noted three persons confessed their guilt and stated that they along with their four other associates were assembled there with deadly weapons for committing road dacoity at Madhyahingli. Accordingly I arrested them after stating them ground of arrest.

After that I along with other force conducted search on the P.O and recovered and seized following articles as shown by the arrested accused persons- i) Few pieces of big boulders, ii) One pair of Chappal left by one of the accused fled away were recovered from the P.O.

I am to further note here that all the arrested persons were interrogated by me one after another and all confessed their guilt implicating themselves and stated that they along with their another four associates namely- i) Sahajahan Khan, s/o- Usman Khan, Vill.- Dhusia, P.S- Chandipur, Dist.- Purba Medinipur and ii) Sk. Motibul of Chanpi, P.S- Mahishadal, Dist- Purba Medinipur, iii) Sk. Babulal of Chanpi, P.S- Mahishadal, Dist- Purba Medinipur, iv) Rahul of Madhyahingli, P.S- Mahishadal, Dist- Purba Medinipur who were managed to escape themselves were assembled there for committing road dacoity at Madhyahingli.

Hence, I would like to pray that a specific case under proper section of law may kindly be started against the arrested accused persons namely- (i) Sk. Saheb (27 yrs.), s/o- Sk. Sahadat Ali, Vill.- Dhusia, P.S- Chandipur, Dist.- Purba Medinipur, (ii) Sk. Sajet Ali @ Sk. Takji (29 yrs.), s/o- Lt. Sk. Amiruddin, Vill.- Babua, P.S- Chandipur, Dist.- Purba Medinipur, (iii) Sk. Alamgir @ Babba (26 yrs.), s/o- Lt. Sk. Fajlu Rahaman, Vill.- Dhusia, P.S- Chandipur, Dist.- Purba Medinipur and iv) Sahajahan Khan, s/o- Usman Khan, Vill.- Dhusia, P.S- Chandipur, Dist.- Purba Medinipur, v) Sk. Motibul of Chanpi, P.S- Mahishadal, Dist- Purba Medinipur, vi) Sk. Babulal of Chanpi, P.S- Mahishadal, Dist- Purba Medinipur, vii) Rahul of Madhyahingli, P.S- Mahishadal, Dist- Purba Medinipur who were managed to escape and arrange for its investigation.
