I, S.I Ajeet Kr. Jha, O.C Mahishadal P.S, Dist. Purba Medinipur do hereby lodge a written complainant as suomotto ,against one Jagannath Pramanik S/o Rabindra Nath Pramanik of Ichhapur , PS Mahishadal , Dist Purba Medinipur to the effect that received a memo from the office of Superintendent of Police vide Memo No-323/RO (HC)/Misc-16 dated-15.12.16 in C/W W.P No-34193 (W) of 2014, Jagannath Pramanik -VS- The state of W.B & other's with W.P No-3117 (W) of 2014. Ritu Maity Rana-VS- The state W.B & other's, where Hon'ble High court, Calcutta ordered that "The petitioner is directed to serve copy of documents to the BDO. Upon receipt of such documents the BDO shall hand over the same to the district Police authorities for a proper investigation into the matter to ascertain whether the computer certificate produced by Sri Jagannath Pramanik is a genuine one. In case the police authorities find that the documents produced by sri Jagannath Pramanik is not a genuine one they shall take immediate action against him in accordance with law"

Accordingly after receiving the said order, sent a letter to the Head Master, Byabattahat Adarsha High School. Byabattahat , Purba Medinipur regarding authentication of Computer certificate of Jagannath Pramanik, S/o- Rabindranath Pramanik of Vill- Icchapur, P.S Mahishadal, Issued from Byabattahat Adarsha High School Computer Training center, Conducted by Webel informatics limited, and also held local enquiry and found that the computer certificate of Jagannath Pramanik is not genuine and also not issued from said school. The Jagannath Pramanik makes a forged computer certificate and used this forged computer certificate as a genuine for applying the post of Gram Rojgar Sevak at Bethkundu Gram Panchayet Mahishadal Block, Dist- Purba Medinipur .

Under the above circumstances, I start a case U/S- 465/466/471 I.P.C against Jagannath Pramanik S/o Rabindra Nath Pramanik of Ichhapur , PS Mahishadal , Dist Purba Medinipur , as he used Forged computer certificate as a genuine for getting job of Gram Rojgar Sevak under M.G.N.R.E.G Scheme at Betkundu G.P. Mahishadal Blok, Dist- Purba Medinipur Vide Mahishadal P.S case No- 12/17 dated 10/01/17 U/S- 465/466/471 I.P.C and A.S.I Susanta Pal of Geokhali B/H under Mahishadal P.S will Pls. investigate this case.
