Sir,

In producing here with the accused person namely Kush Maity@ Bhola 32 years s/o- Lt. Sambhunath Maity of vill- Amritberia PS- Mahishdal Dist- Purba Medinipur along with the seized articles approximately 05 (five) ltrs. of I.D. liquors (Cholai) in a plastic jarikane I, SI Benudhar Panda, C/ 440 Abhijit Das C/394 Bijoy Murmu and C/200 Ramlal Hansda were in special raid duty vide Mahishadal PS C.C No-1543/17, Dt- 05.05.17 and at about 20.45 hrs received a secret source information over phone that one Kush Maity@ Bhola of Amritberia village under Mahishadal PS running a clandestine business by selling of I.D. liquor (Cholai) from his house. After received the information the matter brought to notice before O/C Mahishadal PS and as per kind direction I along with force rushed to place and at about 21.15 hrs we reached at village Amritberia, identified the house of accused Kush Maity@ Bhola and found that he was selling I.D. liquor along with fresh liquors from his house to public. On getting police scent he tried to flee away but manage to apprehend him after a short chase. Accordingly we searched his house in presence of the local witnesses and found approximately 05 (five) litters. of I.D. liquor (cholai) in a plastic Jarikane. On asking the accused Kush Maity fails to produce any valid document/licence in respect of keeping and selling of I.D. liquors. So, I arrest the said accused Kush Maity Maintaining all formalities and seized above quantities of I.D. liquor (cholai) under proper seizure list duly signed by the witnesses and the accused Kush Maity and 375 ml (approx) of I.D. liquors has taken by me as sample in a bottle from the said plastic jarikane.

Under the above facts and circumstances I pray before you that a specific case may kindly be started against the accused Kush Maity@ Bhola 32 years s/o- Lt. Sambhunath Maity of vill- Amritberia PS- Mahishdal Dist- Purba Medinipur under proper section of law.
