

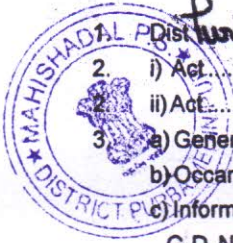

Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003 to the effect that **Sk. Sajjad, S/o- Late Sk. Moksed, Vill + P.O – Rambag, P.S - Mahishadal, Dist:- Purba Medinipur**, has committed theft of electricity under section 135 of the Electricity Act, 2003 read with Amendment Act- 2007 as stated here . On **01.06.2017 at 12.45 p.m.**, I, **Sri Bibhas Roy, D.E & Station Manager**, Mahishadal Customer Care Center, along with **Supratik Bhattacharjee, SAE(E) and Santanu Sarkar (O.E)** of Mahishadal Customer Care Centre visited the premises where **Sk. Sajjad** resides and found that he was consuming electricity by way of **Direct Hooking from Nearest LT-OH line**, causing loss of revenue of WBSEDCL. As theft of electricity was detected during inspection, **a portion of hooking wire** has been seized in the presence of witnesses and their signature obtained on the seizure list. The inspection team left the aforesaid area, at **01.15 p.m.**

The accused **Sk. Sajjad**, has committed an offence under section 135(1)(a) of the Electricity Act, 2003 read with Amendment Act, 2007. Hence you are requested to take cognizance of this complaint and treat it as FIR.
