Complaint filed by the complainant against the accused for the offence of cheating under Section 420 of the Indian Penal Code.

The complainant states that the accused had obtained a loan of Rs. 10,000/- from him on the basis of a false statement that he was a government employee. The accused had used the money for his personal expenses and had not repaid the loan. The complainant has been unable to recover the money and has therefore filed this complaint.

The accused has denied the charges and has claimed that the money was a gift from the complainant. He has also claimed that he has repaid the loan.

The complainant has produced the following evidence in support of his case: a written statement from him to the accused, a receipt for the loan, and a statement from a friend of the accused who had seen him with the money.
