5. That immediately after the detection of her such fraudulent act the Complainant has filed Title Suit No. 231/2011 in the Court of Civil Judge, Jr. Division at Haldia which is pending. Arising out of the said suit, there is an Injunction Order of Hon'ble High Court, Calcutta in C.O. No. 2318 of 2014. Xerox copy is enclosed herewith.
6. That being frustrated in her such illegal bid, Suraiya Bibi (Accused No.1) started hatching other sorts of conspiracy in connivance with other accused persons by projecting the minor Sartaz Khan issue out of wedlock of Nazma Begum and Anwar Hussain Khan projecting him (said minor son) as the biological issue of Samsuddin Ahmed and the accused No.1 Suraiya Bibi and in order to establish the said relationship the accused No.1 in connivance with accused No. 6, Sanat Singh, Ex. Pradhan of Nathshall - II Gram Panchayat procured and manufactured a Birth Certificate of Sartaz Khan, son of Anwar Hossain Khan and Nazma Begum (Accused Nos. 2 & 3) as the son of Suraiya Bibi and Samsuddin Ahmed which was not within the knowledge of the Complainant.
7. That on 24.09.2013 the accused No.1 along with other accused Nos. 2 to 6 made a publicity in the locality and through the said fictitious and forged certificate the accused No.1 in connivance with other accused Nos. 2 to 6 is trying to establish the right of so called Sartaz Khan through false personification.
8. That be it further stated here that the accused No.1 in connivance with the Ration Dealer of Rambagh village, P.S. Mahishadal, Dist. Purba Medinipur has procured a Ration Card in favour of of Sartaz Khan projecting him as Sartaz Ahmed, son of Samsuddin Ahmed.
9. That immediately after having the knowledge the complainant in order to ascertain the authenticity of the said birth certificate filed an application u/s 6 of R.T.I. Act, 2005 before Natshall II Gram Panachayat dated 11.03.2015 and on getting reply from Natshall - II, Gram Panachayat came to know the illegal act of the accused persons.

10. That immediately on receipt of such illegal act the complainant drew attention to all the local people including the Private Witness No. 1 to 3 and complained before the Police Authorities and made a G.D.E. dated 20.02.2015 vide MDL G.D.E. No. 957 before Mahishadal P.S. and copy of the said complaint sent to the concerned officers of Administration and personally met with them and requested to register a specific case and arrest the accused persons but they have avoided the complainant on different pleas.
11. That lastly on 2/2/16 as and when the complainant met with O/C, Mahishadal P.S. to know about the fate of his complaint, the concerned O/C asked him to take shelter in the Court of law. Hence, the delay in filing this complaint.
12. That the complainant has filed the relevant forged Birth Certificate, Xerox copy of written complaint dated 20/2/2016 addressed to the Officer-In-Charge, Mahishadal Police Station with a copy to Circle Inspector of Police, Mahishadal Sub-divisional Police Officer, Haldia, Durgachak, Addl. Superintendent of Police, Haldia, Superintendant of Police, Purba Medinipur at Tamluk, Sub-Divisional Officer, Haldia along with this complaint and he will refer other relevant documents to the concerned I.O. at the time of investigation.

It is, therefore, prayed that your honour may graciously be pleased to send this Complaint to O/C, Mahishadal P.S. u/s 156(3) Cr.P.C. treating the same as F.I.R.
