Sir,

In producing here with the accused person namely Srikrishna Guchhait (56 yrs) S/O-Rasik Guchhait of vill-Amritberia, PS- Mahishdal Dist- Purba Medinipur along with the seized 10(ten) ltrs. (approx) I.D. liquors (Cholai) in a plastic Jarikane.

I, S.I. Biswanath Kayal of Mahishadal PS do hereby lodge a written complaint against the accused Srikrishna Guchhait to the effect that today on 29.06.17 myself along with C/-919 Rathindranath Dedalal, C/1582 Sandip Nayak and C/290 Prasanta Manna were in evening patrolling duty vide Mahishadal PS C.C. no-2148/17 dated 29.06.2017 and at about 18:25 hrs received a source information that one namely Srikrishna Guchhait S/O-Rasik Guchhait of vill-Amritberia, PS- Mahishdal Dist- Purba Medinipur under Mahishadal PS running a clandestine business by selling of I.D. liquor (Cholai) at his house. I informed O/C Mahishadal PS and as per his instruction myself with force rushed to place and at about 19:05 hrs we reached at Amritberia and identified the house of accused Srikrishna Guchhait and found that he was selling I.D. liquor (cholai) from his house. We searched his house in presence of the local witnesses and found 10 litres. I.D. liquor (cholai) in a plastic Jarikane was kept in his house. On asking he fails to produce any valid document/licence in respect of keeping and selling of I.D. liquors (cholai). So, I arrested the accused Srikrishna Guchhait (56 yrs) S/O-Rasik Guchhait of vill-Amritberia, PS- Mahishdal Dist- Purba Medinipur and seized 10(ten) litres of I.D. liquor (cholai) under proper seizure list duly signed by the witnesses and the accused Srikrishna Guchhait and 375 ml (approx) of I.D. liquors has taken as sample in a bottle from the said plastic Jarikane.

Under the above fact circumstance I pray before you that a specific case may kindly be started against the accused Srikrishna Guchhait (56 yrs) S/O-Rasik Guchhait of vill-Amritberia, PS- Mahishdal Dist- Purba Medinipur under proper section of law.
