Sir,

In producing here with the accused persons namely Biswanath Jana (26 Appx) s/o-Sesanka jana of Purba Srirampur, PS Mahishadal, Dist- Purba Medinipur about 04 ltr. the seized articles about 04 ltrs. (approx) I.D. liquors (Cholai) nye plastic jarikane.

I, S.I. Benudhar Panda of Mahishadal PS do, hereby lodge a written complaint against the accused Biswanath Jana (26 Appx) s/o-Sesanka jana of (other name) Srirampur, PS Mahishadal, Dist- Purba Medinipur to the effect that today I took myself along with force were in vide Mahishadal PS CC No-133/17 Date-14/01/2017 engaged Special raid duty. I received a secret source information over phone that O/C Biswanath Jana at Purba Srirampur village under Mahishadal PS running a clandestine business by selling of I.D. liquor (Cholai) at his house. I informed the matter to O/C Mahishadal PS and as per his instruction I along with force reached to place and at about 20.05 hrs I reached at village purba srirampur identified the house of accused Biswanath Jana and found that he was selling I.D. liquor along with other liquors from his house. On getting police scent he tried to flee away but I managed to apprehend him after a short chase. Accordingly I searched his house in presence of the local witnesses and found 04(four) ltrs. I.D. liquor (cholai) in a plastic jarikane was kept in his house. On asking he fails to produce any valid document/ licence in respect of keeping and selling of I.D. liquors. So, I arrested the said accused Biswanath and maintaining all formalities and seized above quantities of I.D. liquor (cholai) under proper seizure list duly signed by the witnesses and the accused Biswanath and 375 ml (approx) of I.D. liquors has taken as sample in a bottle from the said plastic jarikane.

Under the above fact and circumstance I pray before you that a prosecution may kindly be started against the accused Biswanath Jana (26 Appx) s/o-Sesanka jana of Purba Srirampur (Bharatpur), PS Mahishadal, Dist- Purba Medinipur under the section of law.
