I do hereby lodge a complaint empowered by the Electricity Act, 2003 to the effect that SK.Mulasur, S/o.- Lt Golam Rabbani of Vill.-Rambag, P.S- Mahishadal, Dist:- Purba Medinipur, has committed theft of electricity U/S 135 of the Electricity Act, 2003 read with Amendment Act- 2007 as stated here under on 02.01.2017 at 3.30 pm., I, Sri Bibhas Roy, D.E & Station Manager, Mahishadal Customer Care Center, along with 1) Supratik Bhattacharjee, SAE(E) and Amar Gopal Pramanik SAE(E) of Mahishadal Customer Care Centre visited the premises of SK.Mulasur, and found that he was consuming electricity by meter tempering, causing loss of WBSEDCL's revenue. As theft of electricity was detected during inspection, a portion of bypass cable have been seized in the presence of witnesses and their signature obtained on the seized list. The inspection team left the aforesaid area, at 4.00 pm.

The accused SK.Mulasur, has committed an offence U/S 135(1)(b) of the Electricity Act, 2003 read with Amendment Act, 2007. Hence you are requested to take cognizance of this complaint and treat it as FIR. *
