To The Officer-in-Charge, Mahishadal P.S, Dist- Purba Medinipur.

Sir.

In producing here with the accused person namely Sukumar Ghati aged 54 years s/o- Lt. Jharucharan Ghati of vill- Chak Gajipur, P.S- Mahishadal, Dist- Purba Medinipur along with the seized articles approximately 06 (Six) ltrs. of I.D. liquors (Cholai) in a plastic jarikane, I. S.L. Prasanta Kumar Banik of Mahishadal P.S do hereby lodge a written complaint against the accused said Sukumar Ghati to the effect that today on 06.02.17 myself along with C/1569, Tarun Manna, C/440, Abhijit Das were in raid duty vide Mahishadal P.S, C.C. no-332/17 and at about 18:25 hrs received a secret source information over phone that one Sukumar Ghati of Chak Gajipur under Mahishadal PS running a clandestine business by selling of I.D. liquor (Cholai) from his house. I informed the matter to O/C, Mahishadal P.S and as per his instruction myself and accompanied force rushed to place and at about 19:05 hrs we reached at village Chak Gajipur, identified the house of accused Sukumar Ghati and found that he was selling LD. liquor along with fresh liquors from his house to the public. On getting police scent he tried to flee away but manage to apprehend him after a short chase. Accordingly we searched his house in presence of the local witnesses and found approximately 06 (Six) fitrs. of I.D. liquor (cholai) in a plastic jarikane. On asking the accused Sukumar Ghati fails to produce any valid document/licence in respect of keeping and selling of LD. liquors, So, I arrest the accused said Sukumar Ghati maintaining all formalities and seized approximately 06 (Six) ltrs. of I.D. liquors (Cholai) in a plastic jarikane under proper seizure list duly signed by the witnesses and the accused and 375 ml (approx) of I.D. liquors has been taken by me as sample in a bottle from the said plastic jarikane.

Under the above fact and circumstance I pray before you that a specific case may kindly be started against the accused Sukumar Ghati aged 54 years s/o- Lt. Jharucharan Ghati of vill-Chak Gajipur, P.S- Mahishadal, Dist-Purba Medinipur under proper section of law.
