In producing herewith arrested accused person namely Sanu Jadav, s/o Jagru Jadav of vill- Barahima, PS- Mahammadpur, Dist. Gopalganj, State Bihar at present residing at Kanchanpur Jalpai, Kapasaria, PS- Mahisadal, Purba Medinipur along with a consignment of 05 (five) nos. of iron made barrels loaded with petroleum product each capacity 200 (two hundred) ltrs. total approximately 1000 (One thousand) ltrs. and 01 (one) liter sample of petroleum product taken from the above container/barrels as sample for its expert examination.

I SI, Bansidhar Banerjee of DEB, Purba Medinipur do hereby lodged a written complaint against the accused person namely Sanu Jadav, s/o- Jagru Jadav of Vill- Barahima, PS- Mahammadpur, Dist. Gopalganj, Bihar to the effect that today (28.12.16) at 14.30 hrs. we received a secret source information regarding illegal/clandestine business of selling petroleum product at Kanchanpur Jalpai, Kapasaria, PS- Mahisadal. After investigation by Dy. SP, DEB, Purba Medinipur and as per instruction myself along with Asst. Tapas Paul, Indrajit Das, WO-291 Rabindranath Bari of DEB Purba Medinipur left for Mahisadal PS after reaching at Mahisadal PS informed the matter to OC, Mahisadal PS and requested to render police assistance. After that we alongwith SI Prasanta Banik, C/1649, No. C/1582 Sandip Nayek of Mahisadal PS left for PO to work out the source information noting in Mahisadal P.S GDE NO. 1206 dt. 28.12.16. At 14.35 hrs. when we reached there we found that some persons are selling petroleum products from the makeshift godown. After chase we are managed to apprehend one person while some other miscreants escaped away from there. On interrogation the apprehended person disclosed his identity name Sanu Jadav, s/o- Jagru Jadav of vill- Barahima, PS- Mahammadpur, Dist. Gopalganj, Bihar presently residing in a makeshift godown at Kanchanpur Jalpai, Kapasaria, PS- Mahisadal, Purba Medinipur. He also confessed that he and Narayan Pradhan @ Khokon, s/o- Lt. Ramkrishna of 38 Bekarganj, PS- Belghoria, Kolkata 700056 at present residing at Kanchanpur Jalpai, Kapasaria, PS- Mahisadal, Purba Medinipur are running the said illegal business of storing and selling of the petroleum product, but he failed to produce any paper in support of selling/storing of petroleum products. Accordingly, after lapse of reasonable time we available witnesses namely i) Bhakti Mal, s/o- Lt. Bhushan Ch. Mal of Vill & PO- Mahisadal, Purba Medinipur ii) Mangal Jana s/o- Lt. Belaram Jana of vill- M. Nandkumar, Purba Medinipur and iii) Sadhan Singh, s/o- Lt. Ratan Singh of vill- Khokon, PS- Mahisadal, Purba Medinipur, the following articles were seized after preparing proper list duly signed by the witnesses and took thumb impression of accused person. Seized articles are as follows i) 05 (five) nos. of iron made barrels loaded with petroleum product each capacity 200 (two hundred) ltrs total approximately 1000 (One thousand) ltrs. and ii) 01 (one) liter sample of petroleum product taken from the above seized barrels as sample for its expert examination. The seized articles kept at Mahisadal PS compound.

On interrogation the apprehended person confessed that the said illegal business is running by he and Narayan Pradhan @ Khokon, s/o- Lt. Ramkrishna of 38 Belghoria, Belghoria, Kolkata 700056 without any valid license/documents. He also informed that the name of the land owner is Mithu Roy of Vill Khadi, Mahisadal PS, Purba Medinipur. We arrested Sanu Jadav, s/o- Jagru Jadav of vill- Barahima, PS- Mahammadpur, Dist. Bihar after observing all formalities and informed him ground of arrest, as he is liable under section 3(d) of Essential Commodities Act X/55 and he is liable for prosecution under section 7(1)(d) of Essential Commodities Act X/55.

After returning at the PS along with arrested accused person and report of investigation submitting a written complaint to start a specific case against the accused person namely Sanu Jadav, s/o- Jagru Jadav of vill- Barahima, PS- Mahammadpur, Dist. Bihar and present residing at Kanchanpur Jalpai, Kapasaria, PS- Mahisadal, Purba Medinipur and Narayan Pradhan @ Khokon, s/o- Lt. Ramkrishna of 38 Bekarganj, PS- Belghoria, Kolkata 700056 at present residing at Kanchanpur Jalpai, Kapasaria, PS- Mahisadal, Purba Medinipur under section 7(1)(d) of Essential Commodities Act X/55 for investigation.
