**Sub: Incidence of forceful taking over of possession of mortgaged property acquired by the Authorized Officer of our Bank on application of SARFAESI ACT'02 by Sri Biswas Ranjan Maity S/O Nirapada Maity of Vill.- Keshabpur, Jalpai, Mahisadal (accused).**

Towards security of loan facilities sanctioned by Allahabad Bank Terapekhia Branch in favour of Sri Biswas Ranjan Maity S/O Nirapada Maity of Vill.+ P.O.- Keshabpur Jalpai, Mahisadal Dist.-Purba Medinipur, L& B situated at Mouza- Keshabpur Jalpai (J.L.No. 133) Plot No 4717(LR) Kh.No.1936(LR) was mortgaged in favour of the Bank by the above referred owner of the property. Upon defaulting in making payment of such loan obligation as per terms of sanction, the authorized officer of the creditor Bank took physical possession of the said asset as per law of the land on 25.01.2017. Two security guards were deployed by the authorized officer to look after the said property (Sri Krishna Gopal Kula S/O Suk Chand Kula of Vill.+P.O.- Kulberia, P.S.-Tamluk-721649 & Sri Pabitra Hazra). I being the Branch Manager of Allahabad Bank, Terapekhia Branch was entrusted to act as local in charge of the property on behalf of the authorized Officer. It is not out of place to mention here that a seizure list of movable articles found within the said premises at the time of taking physical possession was prepared in presence of a number of witnesses including the undersigned and Pradhan of local itamagra GP. Since, the mortgager Sri Biswas Ranjan Maity refused to sign and accept such seizure list, notification was published by the authorized Officer on 30.01.17 & 05.02.17 in leading Bengali daily News paper requesting such Biswas Ranjan Maity to collect such articles found at the time of taking Physical possession.

Under the above back drop, I am to inform you that today(10.02.17) at about 8.45am it was informed to me over cell phone by one of the security guard Sri Krishna Chand Kula that the said Sri Biswas Ranjan Maity forcefully entered into the premises by manhandling him and unlawfully took possession of the premises. On getting the message I with my colleague rushed to the spot and try to talk to the trespasser to justify his action. In reaction, Said Biswas Ranjan Maity attempted to attack us physically with chopper (Katan) i.e. Iron made wood cutting weapon and threatened me and my colleague with dire consequences, if we did not leave the place immediately. Somehow, we escaped from the site for our own safety.

Under the above situation, I request you to take appropriate action against the culprit to meet the end of justice and ensure safety of the mortgaged property as well as safety of me and my colleague.
