In producing herewith the one arrested accused person namely – Akshay Jana (40 yrs.) s/o- Lt. Badal Jana of Vill- Dakshin Purba Srirampur, P.S- Mahishadal, Dist- Purba Medinipur with 06 litres (approx) I.D. liquor (cholai) in a plastic Jarikane and 375 ml (approx) of I.D. liquors has taken as sample in a bottle from the said plastic Jarikane on 03.01.2017 evening I S.I-Biswanath Kayal with S.I, Prasanta Kumar Banik, Const-919 Rathindranath De Dalal and Const- 1569 Tarun Manna , CC no- 29/17 dated-03.01.17 were in a evening mobile duty at PS area, on 03.01.17 at 19:55hrs I received a source information that one Akshay Jana of Dakshin Purba Srirampur under Mahishadal P.S running a clandestine business by selling of I.D. liquor (Cholai) from his house. I informed the mater to O.C Mahishadal PS and as per direction I along with other officer and force reached at Dakshin Purba Srirampur village at 20:05 hrs and identified the house of Akshay Jana and found that he was selling I.D. liquor (cholai) from his house. I searched the house of accused Akshay Jana in presence of the local witnesses and found 06 litres.(approx) I.D. liquor (cholai) in a plastic Jarikane was kept in his house. On asking he fails to produce any valid document/licence in respect of keeping and selling of I.D. liquors (cholai). So I arrested the Akshay Jana (40 yrs.) s/o- Lt. Badal Jana of vill- Dakshin Purba Srirampur, P.S- Mahishadal, Dist- Purba Medinipur and seized 06 litres (approx) of I.D. liquor (cholai) under proper seizure list duly signed by the witnesses and the accused Akshay Jana and 375 ml (approx) of I.D. liquors has taken as sample in a bottle from the said plastic Jarikane.

Under the above fact circumstance I pray before you that a specific case may kindly be started against the accused Akshay Jana (40 yrs.) s/o- Lt. Badal Jana of vill- Dakshin Purba Srirampur, P.S- Mahishadal, Dist- Purba Medinipur under proper section of law.
