Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003 to the effect that **Lababdi Mallick, Vill-Garkamalpur, P.S- Mahishadal, Dist:- Purba Medinipur**, has committed theft of electricity under section 135 of the Electricity Act, 2003 read with Amendment Act- 2007 as stated here. On 13.02.2017 at 11.30am., I, **Sri Bibhas Roy, D.E & Station Manager**, Mahishadal Customer Care Center, along with **Milan Kumar Mandal, L.M and Amar Gopal Pramanik SAE(E)** of Mahishadal Customer Care Centre visited the premises where **Lababdi Mallick** resides and found that he was consuming electricity by **Service cable tempering**, causing loss of WBSEDCL's revenue. As theft of electricity was detected during inspection, a portion of tempered service cable and portion of electric wire using in tampering has been seized in the presence of witnesses and their signature obtained on the seizure list. The inspection team left the aforesaid area, at 12.00 pm.

The accused **Lababdi Mallick**, has committed an offence under section 135(1)(b) of the Electricity Act, 2003 read with Amendment Act, 2007. Hence you are requested to take cognizance of this complaint and treat it as FIR.
