Sir,

In connection with the above this is to inform you that an untoward incident took place on 01.03.2017 at about 11.30 a.m. at Keshabpur Jalpai while effecting the new service connection to Sri Sukdeb Maity, S/o- Late Bhushan Ch. Maity. It is noteworthy that a few no. of poles are required for effecting this service connection. But poles can not be erected and LTOH line can not be drawn due to strong objection and physical resistance by Smt. Malati Maity, W/o- Sri Dulal Maity and Smt. Kajal Maity, W/o- Sri Purna Chandra Maity, resulting in non-effecting of new service connection to Sri Sukdeb Maity. At the time of execution of the said work Smt. Malati Maity and Smt. Kajal Maity and other local people manhandled the personnel of WBSEDCL on duty at that place. They also used abusive language towards the personnel engaged for the work. Smt. Malati Maity, Smt. Kajal Maity and others prevented and obstructed the personnel of WBSEDCL to carry out the above mentioned work of effecting new service connection to the indenting consumer.
