- 65 (Pive) K.Gs 100 (one hundred) Gms. (approx.) of loose ganja labeled & sealed in a hlue colour plastic bag inside a bag over which "Diamond Plastics Private Limited" was written, marked as Exhibit "A" (main stock)
- One big iron made, weighing balance whose plates were made of Aluminum.

3) One small weighing balance made of brass,

4) One suissor on which "STAINLESS STEEL" is written.

5) (i5(Five) iron made weight of 1 kg, 500 gms, 200 gms, 100 gms, 50 gms respectively

SI no.-(2) to (5) sealed and labelled in a packet, marked as Exhibit "B".

And do hereby lodge a written complaint as Suo Moto against SK. Abul S/O Sk. Mabud of Vill- Gajipur, PS Mahisadal, Purba Medinipur to the effect that today i.e on 04.03.17 at 15:05 hrs I received a secret source information from a reliable source that one person namely SK, Abul S/O Sk, Mabud of Vill- Gajipur, PS Mahisadal, Purba Medinipur , would be kept some amount of ganja in his house at Vill-Gajipur under PS Mahisadal for selling the same to someone in exchange of money. I examined the source properly. On examining the source, information appeared to be reliable & credible. Immediately I informed my superiors ( C.I. Mahisadal , S.D.P.O Haldia, Addl S.P. Haldia, etc) about the details of the source information. over telephone. C.I Mahisadal was pleased to direct me to work out the source information and also directed me that he will contact B.D.O Mahisadal for conducting the search in case the need. arises. I diarized the information vide Mahisadal PS G.D.E No-151 dated- 04.03.17. Accordingly myself along with A.S.I Arnab Banerjee , C/1045 Nikhil Singh, C/- 919 Ratindranath Dey Dalal , L.C/562 Basanti Das left PS accompanied by my source with PS Vehicle No- WB 29A/0431 equipped with necessary articles like weighing balance, weight ranging from 10 gms to five kgs, paper, carbon paper, brown paper, pen, scale, stamp .pad. senling wax, metal specimen scale, candle, matchbox etc to work out the source information This has reference to Mahisadal PS G.D.E. No. 152 dtd. 04.03.17 at 15:15 hrs. We arrived near Gajipur at 15:40 hrs and keeping the vehicle at a distance in a by-lane, we walked down towards the house of Sk Abul. On way I requested local disinterested respectable pedestrians namely - i) Sk. Rejabul (34 yrs) S/O- Sk. Mansur of Gajipur, P.S- Mahishadal, ii) Sk. Yeunish Ali (29 yrs.) s/o- Sk. Mahammad Ali of Rambug, P.S.- Mahishadal. (iii) Sk. Jakir Hossain (33) yrs.) s/c- Lt. Sk. Riyased Hossen of Gajipur, P.S.- Mahishadal all of Dist. Purba Mediniour who happened to the place for their personal business ( work) to accompany police Party in holding raid Program, all of them voluntarily agreed to my proposal to accompany. Police party as witness. However, 1 disclosed my identity as S.I Ajeet Kr. Jha O/C Mahisadal PS, Then I stated before them the nature of raid. It indeed all of my accompanying officers /force about the mature of raid and purpose of the police operation. We rushed towards the house Sk. Abul. with the above mention witnesses.

We reached Gajipur Dakshin Pally at 15:55 hrs and as per information and shown by my source identified the suspected persons house at Gajipur village, after identification we tried to cordon his house but found one person manage to flee away towards betel garden (Panbaroj). On local inquiry it is learned that the escape person name is Sk. Abul (50 yrs. approx.), s/o. Sk. Mabud, Vill.- Gajipur, P.S. Mahishadal, Dist.- Purba Medinipur. I informed the development to Shri Supriya Basu C.I Mahisdal over phone and requested him to come to the spot himself or with an executive Magistrate as I have every reason to believe that the N.D.P.S urticles is kept in suspected house as seeing the police personnel he (SK. Abul.) escaped towards betel garden (Pan baroj). C.I Mahisadal then instructed me to proper cordon the

suspected house and replied that he would be reaching very soon as the B.D.O. Mahisdal (Executive Magistrate) could not be contacted as he was not available at his office at that time, Sri Supriya Basu, C.I Mahisadal arrived at the spot at 16:45 hrs and disclosed his identity as Gazetted officer, of Govt, of West Bengal before the local witnesses and informed the witnesses about the reason of his arrival...

As per order and in presence of C.I Mahisadal I searched the suspected House and

during search and found the following articles

Some amount of loose ganja in a blue colour plastic bag inside a bag over which "Diamond Plastics Private Limited" was written,

One big iron made weighing balance whose plates were made of Aluminum,

One small weighing balance made of brass, 3)

One scissor on which "STAINLESS STEEL" is written,

05(Five) iron made weight of 1 kg, 500 gms, 200 gms, 100 gms, 50 gms respectively in 4) 5) the attached kitchen room of the house Sk. Abul

Under instruction of C.I Mahisadal . I measured the said Ganja by weighing balance ( which was also found at kitchen room ) and found to be Five K.Gs 100 Gms( approx.) I packed, labeled and sealed the main stock containing 5 K.Gs 100 Gms of Ganza marked as exhibit - A and seized or labeled the rest S.L No- 2 to 5 as noted above marked as Exhibit- B under proper seizure list after maintaining all formalities of search & Seizure with the signature of witnesses. On asked the neighbor and local witnesses it is found that he ( Sk Abul ) possessing Ganja in his house and daily sells to some one in exchange of money. Then I held raid in and around Gajipur village at several suspected places but he was not found.

The whole process of seizure started from 16:55 hrs and concluded at18.25 hrs on 04.03.17. On 04.03.17 at 18:455 hrs myself along with seized articles and all the police personals left P.O for P.S. I reached P.S at 20.05 hrs, assumed the Charge of PS and started a case u/s 20 (b) (ii) (B) NDPS Act 1985 against the accused SK, Abul S/O Sk, Mabud of Vill-Gajipur, PS Mahisadal, Purba Medinipur as Suo Moto vide Mahisadal PS Case No- 70/17 dtd-04.03.17 U/S- 20 (b) (ii) (B) NDPS Act 1985 and S.I Prasanta Kr. Banik will please investigate

this case.
