In producing here with the accused person namely Srikanta Mzndal (33 yrs) s/o- Lt. Rampada Mandal of vill-Dakshin Purba Srirampur, PS- Mahishdal Dist- Purba Medinipur along with the seized 08 ltrs. (approx) I.D. liquors (Cholai) in a plastic Jarikane.


I, S.I. Biswanath Kayal of Mahishadal PS do hereby lodge a written complaint against the accused Srikanta Mzndal to the effect that today on 09.03.17 myself along with C/-1045 NikhilSingh, C/1582 Sandip Nayak and C/1352 Utpal Chalak were in spl raid duty vide Mahishadal PS C.C. no-968/17 dated 09.03.2017 and at about 19:25 hrs received a source information that one Srikanta Mznda s/o- Latel Rampada Mandal of vill-Dakshin Purba Srirampur, under Mahishadal PS running a clandestine business by selling of I.D. liquor (Cholai) at his house. I informed O/C Mahishadal PS and as per his instruction myself with force rushed to place and at about 20:05 hrs we reached at Dakshin Purba Srirampur and identified the house of accused Srikanta Mzndal and found that he was selling I.D. liquor (cholai) from his house. We searched his house in presence of the local witnesses and found 08 litres. I.D. liquor (cholai) in a plastic Jarikane was kept in his house. On asking he fails to produce any valid document/licence in respect of keeping and selling of I.D. liquors (cholai). So, I arrested the accused Srikanta Mzndal and seized 08 litres of I.D. liquor (cholai) under proper seizure list duly signed by the witnesses and the accused Srikanta Mzndal and 375 ml (approx) of I.D. liquors has taken as sample in a bottle from the said plastic Jarikane.

Under the above fact circumstance I pray before you that a specific case may kindly be started against the accused Srikanta Mzndal (33 yrs) s/o- Lt. Rampada Mandal of vill-Dakshin Purba Srirampur, PS- Mahishdal Dist- Purba Medinipur under proper section of law.
