Akhtaruddin, Vill - Sukhlalpur, P.O - Geonkhali, P.S -Mahishadal, Dist:- Purba Medinipur, has committed theft of electricity under section 135 of the Electricity Act, 2003 read with Amendment Act- 2007 as stated here.
