Sir,

I do hereby lodge complain empowered by the Electricity Act - 2003 to the effect that Abdul Rasid Khan, S/o- Lt. Abbas Ali Khan, Vill.& P.O. - Kalindi, P.S. - Mandarmoni Costal has committed theft of electricity U/S - 135(i)(b) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 02/03/2017 at about 1.00 p.m. I, Sri Manas Maity, AE (U), S&LP, Contai Division office along with Sri Jayanta Panda, AE & SM, Sri Abhijit Ghara, LM, and others all attached with Pichaboni C.C.C. inspected the premises after maintaining all formalities of Abdul Rasid Khan residing at Kalindi. During inspection it was found that Abdul Rasid Khan is using electricity by way of direct hooking from the nearby LTOH line of WBSEDCL through two nos. yellow coloured PVC coated 2.5 sq. mm copper conductor for bypassing the energy meter in respect of Consumer Id No: 223012830, Meter No: B2876870, in view of less recording of unit or energy in to the energy meter, causing loss of revenue of WBSEDCL.

Therefore, as theft of electricity was detected in the manner of U/S- 135(i) (b) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was domestic with detected load of 1.18 KVA. The unauthorized hooking line as well as said service connection were disconnected and removed at site and some portion of two nos. separated single core yellow coloured PVC coated 2.5 sq. mm copper conductor along with hooking device of length 2 meter each approx were seized in the presence of witness. Sahanara Bibi, W/o- Abul Hossain Khan, daughter-in-law of the accused was present during inspection and acknowledge the same by putting her signature on the seizure list, inspection report as well as label also. Signature of witnesses are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 1.30 p.m. on 02.03.2017.

Therefore you are requested to take cognizance of this complain and treat it as FIR.
