Sir,

I do hereby lodge a complain empowered by the Electricity Act - 2003 to the effect that Sri Jadab Chandra Barai, S/o- Late Raghu Nath Barai, Vill. - Kalindi, P.O. - Kalindi, P.S. - Mondarmoni Costal has committed theft of electricity U/S - 135(i) (a) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 07/03/2017 at about 12.05 p.m. I, Sri Jayanta Panda, AE & SM, Pichhaboni C.C.C along with Sri Rajkishor Das, TSH, Sri Rajendra Bhuniya, TSH and others all attached with Pichhaboni C.C.C inspected the premises of Sri Jadab Chandra Barai residing at Kalindi after maintaining all formalities. During inspection it was found that Sri Jadab Chandra Barai is using electricity by means of direct hooking from nearby LTOH line, causing loss of revenue of WBSEDCL.

Therefore, as theft of electricity was detected in the manner of U/S- 135(i) (a) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was commercial with detected load of 0.877 KVA. The unauthorized line was disconnected and removed at site.

Some portion of two separate single core copper wire yellow in colour along with hooking device of length 6 feet approx were seized in the presence of witness and signature are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 12.20 p.m. on 07/03/2017.

Therefore you are requested to take cognizance of this complain and treat it as FIR,
