Dear Sir,

I do hereby lodged a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Narayan Ch. Bera, S/O- Lt. Ramani Kanta Bera of Vill: Jamrah Shyampur, P.O-Bodhra, P.S-Mandarmoni Costal , Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 22.12.2016 at about 02:50 PM, I Sri Bhutnath Mudi, SAE & SM, Digha CCC along with Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, and Sri Nandalal Malli, Hg. Sr. LM (ME-4), Digha CCC and others had been to the Vill: Jamrah Shyampur, P.S-Mandarmoni Costal for routine inspection purpose. At first we went to the Domestic premises Sri Narayan Ch. Bera, S/O- Lt. Ramani Kanta Bera of Vill: Jamrah Shyampur, P.O-Bodhra, P.S-Mandarmoni Costal, Dist-Purba Medinipur and during inspection it was found that Sri Narayan Ch. Bera, S/O- Lt. Ramani Kanta Bera of Vill: Jamrah Shyampur, P.S-Mandarmoni Costal, Dist-Purba Medinipur consuming electricity unauthorisedly by the way of direct hooking through 2 nos blue colour PVC coated 2.5 sq mm copper conductor for bypassing the energy consumption into the energy meter for his wrongfull gain in respect of Consumer Id No: 223186591, Meter No: P004871, for less recording of energy through the energy meter installed, causing loss of revenue to WBSEDCL in the tune of load 0.88 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 2 core blue colour PVC coated copper conductor of length 2 (two) meter (approx) along with hooking device were seized under memo of seizure list in presence of witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of Sri Narayan Ch. Bera, S/O- Lt. Ramani Kanta Bera and signature of witnesses and accused obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 03:10 PM.

Thus Sri Narayan Ch. Bera, S/O- Lt. Ramani Kanta Bera of Vill: Jamrah Shyampur, P.O- Bodhra, P.S-Mandarmoni Costal, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
